5. You will be responsible for the overall efficiency and effectiveness of academic and administrative activities at Distance Education Study Centre. BYE-LAWS

AAI-DU Directorate of Distance Education

1.0 PREAMBLE

1.1 AAI-DU being a State Govt. funded/aided Deemed University, has sought and acquired NOC/permission of the State Government of U.P. to start Distance Education Programme, vide G.O. No. 1630/12-8-2002-900(9/2001 dated 15th Feb 2002 (Appendix- A).

1.2 For the purpose of conducting Distance Education programmes, the AAI-DU shall establish a Directorate of Distance Education (DDE) (ref clause 2.0)

1.3 The DDE shall open its own Distance Education Study Centres (DESC) in various parts of the Country and abroad in order to run programmes in various fields such as Agricultural Information Systems, Agri-Business Management, Information Technology, Business Studies, Education and Allied Health Sciences and other programmes as per needs of the community. Details of DESC are given in clause 10.0.

1.4 The University shall run these programmes through DDE as per the guidelines of UGC laid down in this regard for all Universities vide DO letter No. F.1-52/99 (CPP-II) dated 4th Aug. 2001 (Appendix B).

1.5 Each DESC shall be headed by a Coordinator appointed by the AAI-DU

1.6 All programmes in Distance Education mode of the DDE shall be self-financed

1.7 The DDE shall control and be overall responsible for smooth functioning of its Distance Education Programmes through its DESCs and all DESC Coordinators shall be responsible to DDE.



1.8 All employees/Faculty/Professionals/Consultants engaged/appointed by the DDE shall be paid salary/honoraria/perks/consultancy out of the income of the Distance Education programmes.

1.9 All the required facilities such as suitable space for office, telephone, fax and computer systems shall be provided to the DDE by AAI-DU.

2.0 Directorate of Distance Education (DDE)

2.1 COMPOSITION OF DIRECTORATE OF DISTANCE EDUCATION (DEC)

The composition of the DDE shall be as follows:-

Chairman	-	Vice-Chancellor, AAI-DU.
Vice-Chairman & Secretary	-	Director (Resident Instructions), AAI-DU.
Joint Secretary	-	Co-ordinator, DDE
Dy Secretary	-	Dy/Asstt. Registrar, Distance Education
Members	-	Registrar, AAI-DU
	-	Finance Comptroller, AAI-DU
	-	Deans of concerned Colleges or concerned HoDs to be nominated by the Vice-Chancellor.
	-	Any other officials of AAI-DU or experts from outside, to be nominated by the Vice-Chancellor.

2.2 Meetings

The DDE shall meet at least twice in each semester.

3.0 Distance Education Programme

The University shall offer degree/Diploma/Certificate programmes in Distance Education mode. The Distance Education programmes shall follow same curricula as prescribed for regular degree programmes offered

by the University. However, any new programme shall require approval of the Board of Studies and Academic Council alike other programmes of the University.

#### 4.0 DUTIES AND RESPONSIBILITIES OF DDE and its functionaries

The DDE shall,

- 4.1. be directly responsible to the Vice-Chancellor of AAI-DU for execution of its programmes,
- 4.2. take necessary steps to ensure that the entire process commencing from the admission of students in any programme up to the award of a degree is done efficiently and in a transparent manner,
- 4.3. ensure quality Education in DESCs,
- 4.4. recommend reputed organizations/persons to be appointed as Counsellors/Consultants to AAI-DU.,
- 4.5. to recommend the appointment of Co-ordinators DESC for the approval of the Vice Chancellor
- 4.6. manage within the budget allocated for the functioning of the Council,
- 4.7. report relevant matters to the Academic Council and Executive Council depending upon their nature and merit for approval, etc. Further, the minutes of the DDE shall be submitted to the Academic Council regularly.
- 4.8. maintain its accounts through the Finance Comptroller's office of AAI-DU,
- 4.9. open and maintain bank Account, in the name Directorate of Distance Education AAI-DU A/c" to be operated jointly by:
  - a. Finance Comptroller or Dy. Finance Comptroller AAI-DU, and
  - b. Registrar or Secretary DDE or any other signatories appointed by the Vice-Chancellor,


