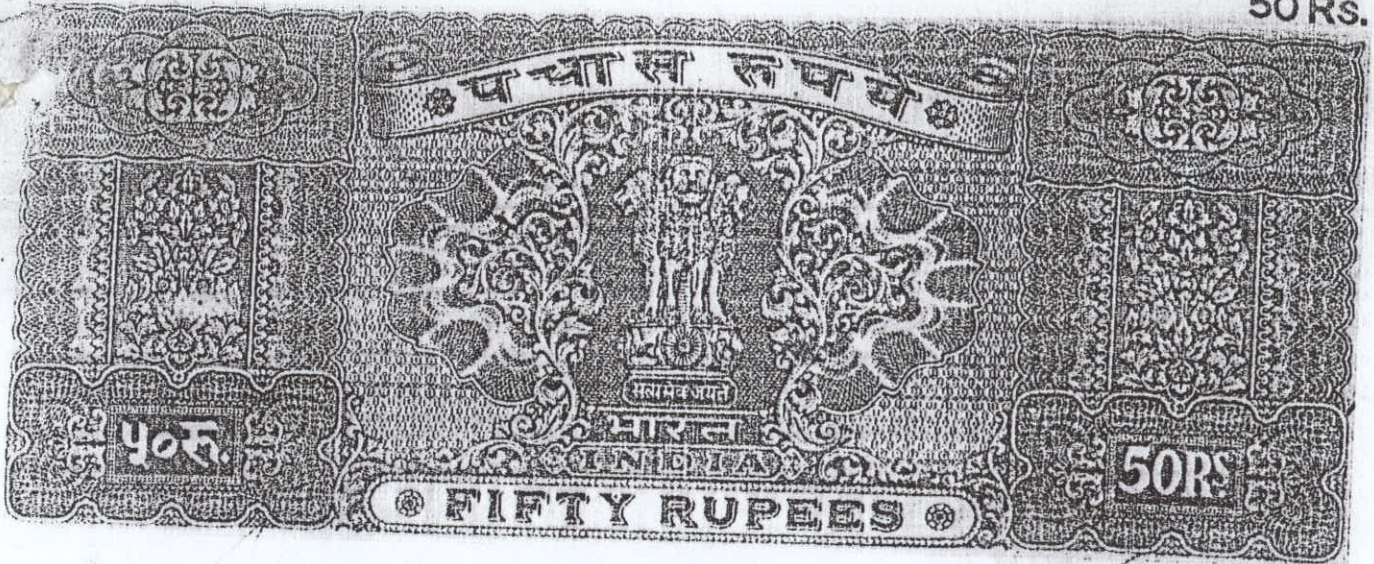

TRUST DEED

THIS DEED OF TRUST IS MADE ON THIS 12/11 DAY OF Oct 1939 BETWEEN SMT. SUDERSHAN BATRA, W/O. SH. S.L. BATRA, Resident of C - 466, Defence Colony, New Delhi, hereinafter called the Founder of the ONE PART ;

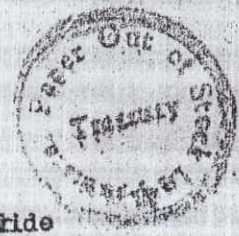

WHEREAS the founder wishes to do Charitable work, Provide free education, open schools, dispensaries, hospitals for the welfare of the poor and down trodden, promote professionalism in education & other fields and has an earnest desire of setting up a Trust for the said pious and charitable purposes and for the objects mentioned hereinafter.

AND WHEREAS, the founder has donated a sum of Rs.5,000/- upon Trust to the Trustees for the purposes of the Trust called "ESEL FOUNDATION" hereinafter described as the Foundation.

AND WHEREAS, the Trustees of the other part have accepted to be invested with the aforesaid Foundation and agreed to be the Trustees of the said Foundation and to accept and receive from the founder the said sum of Rs.5,000/- by Cheque No. 143628 dated 11/10/89 drawn on BANK OF AMERICA, New Delhi, in favour of the Foundation.

AND WHEREAS, the Founder has relinquished all her rights and interest and claim in the said sum of Rs.5,000/- given by her towards the corpus of the said Foundation.

NOW THIS DEED OF TRUST WITNESSETH AS UNDER :-

- (1) That the Founder hereby assigns and pay the said sum of Rs.5,000/- in favour of "ESEL FOUNDATION" for carrying out the object hereinafter mentioned to the Trustees. The said amount of Rs.5,000/- paid by the Founder has been accepted by the trustees and the same is and shall hereinafter be the corpus, property and asset of the Trust.

- (2) That the Trust shall be known as "ESEL FOUNDATION" and will have its office at 10-D, Sagur Apartments, 6, Tilak Marg, New Delhi, or at any other place as the Trustees may hereinafter mutually decide.
- (3) That the Foundation Fund shall be the said amount of Rs.5,000/- to begin with and shall include all acquisitions, contributions, donations, bequests, whether in cash or moveable or immovable property or as income of the Foundation and all transfers of the properties, moveable or immovable in favour of the Foundation.

2. OBJECTS OF THE FOUNDATION :-

The objects for which the Foundation has been created are interalia to provide Free Education to children, Scholarships, set up establish and run schools, welfare centres, Care Centres, Medical Centres and to impart education, and these objects would further include the following :-

- (1) To undertake and carry out research in the fields of humanities and natural, physical, social or applied/science and technology, and to establish administer, manage and maintain libraries, reading rooms, documentation Centres and auditorium for these purposes.
- (2) To institute, offer and grant awards, prizes, trophies fellowships, certificates, medals and



other honours to recognise, encourage and promote excellence in education.

- (3) To establish, sponsor, administer and provide funds, stipends, scholarships and study grants to enable deserving and/or meritorious students, and teachers to pursue their studies research and training.
- (4) To publish books, pamphlets, magazines, journals, reprints and literature and procure produce or purchase, store, utilise and exhibit audio-visual material like recorders, duplicators, cassettes, video tapes, films, fill-strips, flip-charts in furtherance of the objects of the Foundation.
- (5) To establish contacts, collaborate with and enter into arrangements wherever necessary or feasible with other Trusts, organisations, institutions or societies national and international having objects similar to this Foundation for all or any of the objects mentioned in this Deed.
- (6) To utilise mass media like newspaper, magazines, journals, radio and television, through news items, articles, advertisements and write-ups for furthering the objects of the Foundation
- (7) To take, receive, accept or otherwise acquire any gifts, donations, contributions, any money or property,



moveable or immoveable, by gift or otherwise, from persons by legacy, bequest, etc. or by any other mode for any of the objects of the Foundation.

(8) To provide for the training of selected persons for the purpose of the fulfilment and carrying out the objects of this Foundation.

(9) To undertake and/or participate in conferences, seminars symposia and workshops for educating the public about the nature of diseases and their prevention, treatment and cure, as well as the proper attitude which the public should adopt towards the afflicted people.

(10) To encourage and actively involve public for the fulfilment furtherance and achievement of the projects of the Foundation.

(11) To organise, sponsor, promote, develop, conduct and undertake investigations and treatment of human ailments in all possible ways including the latest and modern techniques medical surgical or otherwise.

(12) To establish administer, maintain and provide funds, grants, donations free or subsidised medical aid and other aid and assistance to the poor and the needy, the aged and the infirm, the

deserted and the destitute the handicapped and the helpless.

- (13) To employ, Teachers, Staff, Doctors, Research Scientists, Nurses, Pharmacists, Mid-wives, Specialists, Technicians, Superintendents, Metrons, Secretaries, Clerks, Managers, Servants, workmen and any other personnel and staff required for the proper functioning of the Foundation.
- (14) To invest, dispose of transfer or otherwise deal with the subject matter of the Foundation in such manner as the trustees should deem fit so as to enable the Foundation to carry on its objects effectively.
- (15) To do perform and undertake such other Charitable objects as the Foundation shall consider to be of general public utility and benefit not involving the carrying on of any activity for profit.
- (16) To establish, create, promote, accept and carry out any trusts and to act as Trustees, managers of administrators of any property in furtherance of the objects or for all or any of the purposes of this Foundation.
- (17) To do all such other acts and things as are incidental or as the Trust may consider necessary or



desirable or conducive to the attainment of the above objects or any of them.

- (18) To open schools for imparting secular education to the poor and deserving ones.
- (19) To promote, protect and develop studies in accountancy, legal profession, including Income-tax, Wealth-tax, Excise, Customs and Foreign Exchange and such other fiscal laws as may be enacted from time to time.
- (20) To organise common service facilities for its members and to undertake professional and management consultation services and studies.
- (21) To provide the members and general public with legal assistance under the various fiscal laws.
- (22) To make representations on behalf of the general public and other institutions before the authorities set up under various fiscal laws.
- (23) To make representations and recommendation to the Government for bringing amendments and changes in various fiscal laws.
- (24) To undertake management consultancy and research projects in the field of fiscal laws.
- (25) To establish healthy principles on the conduct of members in the field of management, accountancy and other affiliated profession.

- (26) To make effective steps with a view to procuring just and equitable law and practice affecting members of legal & accountancy professions.
- (27) To encourage the member/students of legal and accountancy profession by awarding certificates, prizes and also to give stipends, scholarship and monetary aid for the growth, advancement and diffusion of fiscal laws.
- (28) To construct, build and maintain, conference halls, libraries, auditoriums etc. for the use of the members of the Foundation.
- (29) To grant scholarships to persons studying in such schools maintained by the Foundation or maintained by other institutions having objects similar to those of the Foundation.
- (30) The objects of the Foundation will not include objects involving to carry on of any activity for profit. It is mutually considered that the objects of the Foundation will be better achieved in the income of the Foundation is exempt under the Income Tax Act. In case, however, any particular clause or clauses of the instrument of Foundation have been inadvertantly clothed in a language capable of interpretation in conflict with the relevant income tax provisions granting exemption, it is hereby agreed that such clause or clauses will have restricted meanings to that the relevant Income Tax Provisions will always have the overriding effect for availing exemption under the Income-tax Act.



3. CONSTITUTION OF THE FOUNDATION :

- (i) The total number of trustees at any time shall not be less than two and not more than eleven.
- (ii) The above names trustees shall from the first Board of Trustees who will from among themselves choose a Chairman and a Vice-chairman.
- (iii) The Board of Trustees aforesaid will remain in office and continue to function as trustees during their life time unless any of them dies or voluntarily resigns or retires or is declared of unsound mind by a Court of Competent Jurisdiction or adjudged insolvent or convicted for an offence involving moral turpitude, or otherwise becomes incapable of acting as a trustee. In such event the remaining trustees will appoint in place of such outgoing trustee or trustees, persons of their choice to replace them and the person so appointed shall function and hold office in the same manner as if they were the founder trustees for all intentions and purposes.
- (iv) The Trustees shall have the powers to appoint a working Board of Directors, If thought expedient, to administer the Trust which shall not be more than seven persons including the founder trustees so first incorporated under this trust deed.
- (v) The first board of trustees shall always remain on the board of the Foundation and shall have the powers to appoint other trustees shall always retire



at the general meeting of the Foundation to be reappointed if thought necessary by the first board of Trustees.

- (vi) If the trustees or the working Board of Directors consider the necessity of appointing other office bearers such as Treasurer, Secretary etc. they shall have the power and competence to make such appointments and to define the powers and functions of such appointees.

4. POWER OF THE TRUSTEES :-

- (i) The Trustees shall have the power and discretion to accept, upon such terms and conditions as they may think fit, any donations or contributions (whether such donations or contributions be in cash or other moveable or immoveable property), provided always that the terms upon which such donations or contributions will be accepted, shall not in any way be inconsistent with or repugnant to the objects of these presents and, if no conditions are attached to any such donation or contributions, the same shall be treated as having been given or made for the furtherance of the objects of these presents.
- (ii) It shall be lawful for the Board of Trustees to settle and determine all matters of interpretation of these presents, as well as all matters of difficulty, doubt or dispute, and all questions arising in the

course of or incidental to the administration, management and execution of the trusts and powers of these presents, and any such settlement of determination (although the question involved may not have been raised) shall be valid, binding and conclusive and shall not be objected to or reopened upon any ground whatsoever.

(iii) The Board of Trustees shall have full power to Settle, compromise or compound out of Court, all suits, actions and other proceedings and to settle and differences and demands and to refer any or all of such suits, actions or other proceedings, differences or demands to arbitration and adjust and settle all accounts relating to the Trust Fund and Property and to execute releases and to do all things relating hereto as fully as if they were absolutely entitled to the Trust Fund and without being answerable for any loss occasioned thereby.

(iv) The Board of Trustees shall be entitled to acquire, construct purchase, hire to take on lease a property or properties for the purpose of carrying out the objects of the Foundation hereby created.

(v) The Board of Trustees may, from time to time, at their discretion and for the furtherance of the objects of this Foundation, borrow moneys at such

rates of interest and in such from and manner and upon security as shall be specified in resolution and, in pursuance thereof make all such disposition of the properties moveable or immovable forming part of this Foundation Fund or any part thereof, and enter into such agreements, assurances, deeds and things in relation thereto as the Trustees may deem proper for giving security for such loans and interests.

- (vi) The Chairman and the working Board of Directors or any person authorised, shall by a Resolution of the Board of Trustees have the powers to institute, in the name of this Foundation all legal proceedings, sign all legal and other documents relating to the property of this Foundation, in any court of law, tribunal or authority for any relief they think fit for the furtherance of the objects and the activities of the Foundation.
- (vii) The Board of Trustees shall invest all moneys forming part of the property or fund of this Foundation and not required for immediate use, in any of the Government Securities or in Fixed Deposits with scheduled or Charter Bank or Central, State or District Co-operative Banks in India or in Public Sector Undertakings or other financial institutions approved for the investment of Trust Funds by the Government. The Trustees shall have the power to vary from time to time or transpose the aforesaid investments into others of the same or a like or other nature.

- (viii) The Trustees may as per resolution recorded in writing, open and maintain in the name of this Foundation any banking account or banking accounts with such scheduled or charter bank or banks Central, State or District Co-operative Bank or Banks as may from time to time be determined by them, and shall forthwith pay or cause to be paid the rents income, and all other moneys forming part of this Foundation Fund to the Credit of any such account or accounts. Such account or accounts shall be operated by any one of the Trustees of this Foundation. Unless otherwise decided by a resolution by the Trustees. Such account or accounts can also be closed by the Trustees, if necessary.
- (ix) The Trustees shall have the power to sell or assign any immovable property or properties for the time being forming part of this Foundation property, either together or in parcels in any manner they deem fit.
- (x) The Receipt in writing of the Chairman or the Working Board of Directors or any person authorised by a Resolution of the Board of Trustee for any interest, dividend of income of this Foundation property or for any deeds, papers, writings, documents or other moneys and effects payable or deliverable to the Trustees shall be a sufficient and effectual discharge for the same respectively as in such receipt or receipts shall expressed or acknowledged to be or to have been received.





- (xi) The Board of Trustees shall, from time to time, be entitled to make Rules and Regulations, alter, amend, substitute or delete them for the administration and management of the Foundation of these presents, and all matters incidental to or concerning the same, provided such Rules and regulations shall not be repugnant to, offend against or be inconsistent with, the provisions of the purposes of the Foundation thereof.
- (xii) The Trustees of these presents are entitled to be reimbursed and also to pay and discharge out of the Foundation Fund for all the expenses incurred by them for the work of the Foundation.
- (xiii) If at any time any trustees act as a whole time office bearer of this trust or renders any special service, the Trustees may in their special service, the Trustees may in their discretion pay him/her such remuneration or allowance as they may think fit and proper.
- (xiv) The Board of Trustees shall be at liberty to allow and permit any other Trust, institution Charity in any Local area or areas; whose objects are the same or similar to those of these presents to the intent and effect that such other Trust, Institution or society shall be deemed to be a part and parcel of the Foundation of these presents provided that no conditions are accepted which are inconsistent with or repugnant to the objects hereof.

(xv) The Trustees shall be free to decide to achieve that objects of this Trust and any one or more of the following method:-

(a) by amalgamating, merging or collaborating with any society established under the Society has the same or substantially similar objects the trust shall agree to amalgamation or merger into such a Society on condition that all the Trustees of this Trust become members of such a society.

(b) to request respectable persons and to associate respectable persons for establishing a Society under the societies Registration Act, 1860 with the same objectives as are the objectives of this trust and to administer this trust through the instrumentality of such a society in such manner as the Trustees may decide while keeping individuality and existence of the Trust also alive the Trustees may decide as to the extent of funds to be released in favour of such a society from time to time for achievements for the objects of the Trust. If and when such a society is established and before the Trustees administered objects of this trust through the instrumentality of this society the Trustees shall ensure that they become the Founder members of such Society alongwith such other persons as may desire to establish such society.

- (c) The Trustees shall also be free to decide to incorporate a Company Limited by guarantee or otherwise with the same objectives as of the trust and also decide whether to merge itself into such a company or to use such a company as a instrumentality as its objects.
- (xvi) The Trustees may delegate any of their powers to one or more Trustees out of themselves or to the working Board of Directors by a formal resolution to be recorded in writing after the same is passed at a meeting held by them or through circulation.
- (xvii) The Board of Trustees for the time being of these presents shall be chargeable only for such moneys, stocks, funds, deposits and securities as they shall actually receive, notwithstanding their signing of any receipt for the sake of confirmity and shall be answerable or accountable only for their own acts, receipts, neglects, defaults, and for those of each other or of any other person with whom or into whose hands any Trust moneys or securities may be deposited or come in accordance with these presents nor for the deterioration or loss of any stocks, funds, deposits, or securities nor any defect or insufficiency of title nor for any other losses unless the same shall happen through their own wilful default.

RULES AND REGULATIONS OF MEETING OF THE TRUSTEES :-

- (1) There shall be held every year, within six months of the closing of accounts of the Foundation Fund, a meeting of the Trustees which shall be called "The Annual Meeting" to transact the following business :-

- (a) to adopt the Annual Report and the Audited Accounts of the Foundation Fund.

- (b) to elect working Board of Directors, Office bearers, when necessary.
- (c) To appoint auditors for the ensuing year, and
- (d) to transact such other business as is required under these presents or Rules and Regulations to be transacted at an Annual Meeting.

ORDINARY OR SPECIAL MEETINGS :-

- (ii) The Secretary or any other appointed office bearer in consultation with the Chairman, shall convene a meeting (called ordinary) of the Board of Trustees to transact such business as he may decide to place before the meeting, and shall, on the requisition of at least three Trustees for the time being of these presents, specifying the business for the meeting, proceed to convene a special meeting of the Trustees to consider the business specified in the requisition.

NOTICE OF THE MEETING :-

- (iii) A meeting of the Board of Trustees, whether Annual, Ordinary, Special, may be called on not less than fourteen clear days notice in writing.

SERVICE OF NOTICE :-

- (iv) A notice of the meeting of the Board of Trustees, whether annual, ordinary, or special, specifying the place, day and hour with a brief statement of the business to be transacted at the meeting shall be sent to every Trustee by post or in such manner as may from time to time be decided.

OMMISSION TO GIVE NOTICE :-

- (v) The accidental omission to give notice or the non receipt thereof shall not invalidate the proceedings at any such meeting.

WHERE MEETING TO BE HELD :-

- (vi) Such meetings may be held at the Head Office of the Foundation or at such other place as the Chairman may from time to time determine.

WHO IS TO CHAIR THE MEETING :-

- (vii) The Chairman of the Board of Trustees and in his absence the one person amongst the Board of Trustees shall preside at all meetings of the Trustees.

QUORUM :-

- (viii) At least one-third, or two of the Trustees for the time being of these presents, whichever is more in number shall from the quorum for the meeting of the Trustees, whether Annual, Ordinary or Special.

NO TRANSACTION OF BUSINESS WITHOUT A QUORUM :-

- (ix) No business shall be transacted at any meeting of the Trustees, whether Annual, Ordinary or Special unless the quorum requisite be present.

WHEN QUORUM NOT PRESENT :-

- (x) If within half an hour from the time appoint for a meeting, a quorum is not present, the meeting shall stand adjourned to such time as the Chairman of the meeting shall determine and, if at such adjourned meeting a quorum is not present those Trustees who are present may transact the business for which the meeting was called. It shall not be necessary to give notice to the Trustees of any such adjourned meeting.

RESOLUTION OF TRUSTEES BY CIRCULAR :-

- (xi) In case of urgency, the Chairman or at his stance the member of the Board of Trustees may circulate any proposal that may arise in the course of the administration of the Trusts of these presents for the opinion of Trustees, giving a fortnight's time for the receipt of the opinion from the date of the despatch of the proposal. If no dissent to the proposal contained in such circular is received within the stipulated period, the proposal shall be deemed to have been passed provided at least one third of the provided at least one third of the Trustees of two of them, whichever is greater, shall have voted in writing for the proposal. All decisions taken by a circular shall forthwith be reported in writing to all the Trustees and shall be placed at the following meeting of the Board of Trustees for information.

RECORDS, ETC. WHERE TO BE KEPT :-

- (xii) All records, title deeds, securities, vouchers, papers and documents relating to the Foundation Fund shall

remain in the custody of such person or persons and at such place or places as may from time to time be determined by the Trustees.

HEAD OFFICE OF THE FOUNDATION :-

- (xiii) The Head Office of the Foundation shall be situated in Delhi or at such other place as may from time to time be determined by the Trustees.

POWER TO APPOINT SUB COMMITTEES AND TO DELEGATE :-

- (xiv) The Board of Trustees may delegate any of their powers to the Working Board of Directors, sub-Committee consisting of such members of their body as they think fit. Any such working Board of Directors or Sub-Committee so formed shall, in the exercise of the powers so delegated confirm to any regulations that may, from time to time, be imposed upon it by the Trustees.

PROCEEDINGS OF SUB-COMMITTEE :-

- (xv) The meetings and proceedings of any working Board of Directors, Sub-Committee shall be governed by the provisions herein contained for regulating the meetings and proceedings of the Board of Trustees so far as the same are applicable thereto and are not superseded by any regulations made by the Board of Trustees under the last preceding clause.

QUESTIONS HOW TO BE DECIDED :-

- (xvi) Questions arising at a meeting of the Board of Trustees shall be decided by a show of hands and in case of equality of votes, the Chairman of the meeting shall have a second or casting vote.

BOOKS OF ACCOUNTS :-

- (xvii) The Board of Trustees shall cause to be kept proper books of account with respect to all sums of money received and expended on account of the Foundation of these presents and the matter in respect of which such receipts and expenditure take place. The Books of account shall be kept at the Head Office of the Foundation or at such other place or places as may from time to time be determined by the Trustees.

ANNUAL AUDIT :-

- (xviii) The Board of Trustees shall have in each accounting year, after the closing of accounts, made and prepared all proper accounts of receipts and expenditure in connection with the management of the affairs of the Foundation hereto showing the same separately under several heads and such accounts shall be audited by a duly qualified Chartered Accountant, appointed every year and only after such accounts are passed at the Annual meeting of the Trustees shall they be made Public.

MINUTES :-

- (xix) The Board of Trustees and the Working Board of Directors shall cause minutes to be duly entered in the books provided for the purpose -
- a) of all resolutions and decisions of the meetings of the Trustees and matters disposed of by circulation;
  - b) of all resolutions and decisions of the meetings of any Sub-Committee or Sub-Committees appointed by the Trustees.

MINUTES CONCLUSIVE EVIDENCE :

- (xx) The draft Minutes of the Proceedings of Meeting of the Board of Trustees, working Board of Directors or of the Sub-Committee shall, in the first instance, be circulated amongst the Trustees or the members of the Sub-Committees as the case may be, and subject to any direction by the Chair person in respect of any suggestions or alterations in the draft that may be received within a fortnight from the date of such circulation, the minutes may be caused to be entered in the respective Minutes Books. Any such minutes of any meeting of the Board of Trustees or any Sub-Committee or Sub-Committees if purposing to be signed by the Chairman of such meeting or by the Chairman of the next succeeding meeting, shall be conclusive evidence of the matters, stated in such minutes. The Trustees have consented to discharge their responsibilities as trusts under this deed and have affixed their signatures
