The same charcoal and hard coke is used as a fuel for tandoors in the Dhabas and Restaurants for preparation of food.

Now, I must add that Dhabas and Restaurants are some of the activities which are allowed in the retail shops from mixed use, and these will also bear a burnt if these activities are not allowed.

Firewood and charcoal is also used by local 'Press Wallahas' (Iron men), who iron the clothes of the local residents to earn their living.

Hence it must be stated that many businesses are dependant and are based on these very raw materials for their own survival, and these businesses will suffer a lot and will eventually themselves be forced to close down in the absence of the availability of these raw materials like coal and firewood around their vicinity.

Moreover, the charcoal used is a smokeless fuel, it is not a highly inflammable as it needs a certain high temperature to catch fire and produces negligible pollution.

Therefore, it is highly suggested to review the clause wherein, these activities should be allowed from mixed land use, with the due consideration and planning.
