Subject: - Suggestion with respect to the provision given in Zonal Development plan of Zone "L" with respect to Najafgarh Town having the site of the community center.

This is reference to the public notice issued by the DDA on 16.2.2012 inviting objection suggestion with respect to the review of master plan / Zonal plan and submissions to be given to the DDA and the respective planning incharge of the various zones.

Najafgarh has been shown as the residential built up area wherein the details of the community center have not been indicated where as in the master plan for delhi -2021 which was notified on 7.2.2012 the zonal level facilities i.e. community center have been indicated, it seems that the zonal plans preparation exercise, provision of MPD-2021 have not been followed the land use especially with respect to the community center in the Najafgarh town has not been shown.

It is further to bring on record that the Najafgarh town a community centre site was proposed in the zonal plan of zone - 'I' and as per the letter received from the ministry of Urban Development on 23.6.89 and prior to that from Dy. Director (MP) on 15.12.1987, (both the photycopy of letter enclosed) that the petrol pumps and cinema hall is a permissible activity in the community centre where the land is owned by the private person. As the area is under jurisdiction of MCD, the details of the community centre are to be prepared by the MCD.

Further it is suggested that in the MPD-2021 the cinema plots or its permissibility and the development controls norms have not been given where as in the master plan for Delhi -2021 Cinema/ temporary cinema was a premises which was allowed to continue at their present location.

It is suggested that in view of the provisions given Development code of MPD -2001 as well 2021 (under clause-3, Establishment of use zone and huge premises under 3(4) that where ever the building plans stands sanctioned by any local / lay out plan which stands approved by any competent authority or local body is deemed to be considered as approved under the provision of master plan for Delhi be followed for our case. The Building Plans of the petrol pump and the cinema hall stands approved by the MCD, at the Khasra no. 26/5 MCD sanctioned the building plan vide their letter no.831/b/hq/121/AE(B) Hq-II dated 1/5/1985 for cinema hall and Khasra no.25/1 MCD sanctioned the building plan vide their letter no.94/A/HQ/78/ dated 30/5/1978 on 6/3/1979 for petrol pump and accordingly completion certificate was issued by the building dept. MCD vide letter 43/CC/84 dated 10/11/1983. Both these plans sanctioned as per the land use of the area. (photocopy of sanctioned and completion letter enclosed.) Therefore these sanctioned plans should be honored without levy of any conversion charges from the owner of these premises.

In view of the above it is humble submission that the master Plan -2021 document be modified and approved to avoid disparity to the actual user as per sanctioned plan and approval by the local authority i.e. MCD in the community centre najafgarh Zone in the past.


