Respected Congress President,

May I like to inform your excellency that many aggrieved residents of Punjabi Bagh Colony have approached me stating that their cases for part properties where arbitration award has been given apart from legal division of joint property is ordered in their favour by the Hon'ble Courts, despite the above facts M.C.D. is not considering their independent registry issued after the joint property divided referred to above. And whereas M.C.D. had approved their Map for construction earlier for their divided portion referred to above is not considering the cases for additional construction as per rules. I don't think that M.C.D. has many rules to follow to suit people of their choice which speaks of dishonesty and disparity.

To my mind, it is really some thing beyond surprising that M.C.D. is not approving their Maps for additional construction on the same premises as per rules as in other cases saying that they don't have independent property as clarified above and call it part property to reject their maps. 
