Dear Shri Kamal Nath Ji,

Please find enclosed copies of representations from Shri Ram Singh Netaji, MLA from Badarpur Assembly and Municipal Councillors as well as RWAs from the area requesting for re-classification Meethapur and Jaitpur Wards from 'O' Zone to 'F' Zone for your sympathetic consideration and necessary action.

I have carefully gone through the representations and fully share their views regarding the situation of the abovesaid Meethapur and Jaitpur and adjoining unauthorized colonies (which have been issued Provisional Certificate of Regularisation and are in the process of being regularized) much far away from the Yamuna River which are located at a distance ranging from 3 to 6 kms. from it. In fact, villages of Haryana are in evistence between these villages and River Yamuna. On the other hand, the colonies which are within 1 km. from the River Yamuna like Gandhi Nagar, Laxmi Nagar and Shakarpur have been shown in Zone 'P'. As such, there is imperative need for change in the re-classification of the Zone of the abovesaid villages i.e. Meethapur, Jaitpur and their adjoining anauthorized colonies from Zone 'O' to Zone 'F'.

Considering the fact that Meethapur and Jaitpur are located at a distance ranging from as much as 3 kms, to 6 kms, from the River Yamuna, these villages and their adjoining colonies are located in Badarpur Assembly area which has been classified in 'F' Zone. Being in contiguny of Badarpur, they rightly deserve to be reclassified from Zone O' to Zone 'F' Zone which will be in conformity with the universal accepted practice of classifying contagious areas in one Zone. This will also provide the much needed relief to the lakks of poor people living in the abovesaid villages and colonies as a matter of equity and fair play.

In view of the position explained above I request you to kindly exercise your good offices for issuing necessary instructions to the concerned officials of DDA for reciassification of Meethapur, Jaitpur and their adjoining unauthorized colonies in Badarpur Assembly from Zone 'O' to Zone 'F' as a token of our concern for the welfare of lakhs people belonging to economically weaker sections of the society living in the abovesaid villages and adjoining unauthorized colonies.

I sincerely hope that the matter would 'receive your rightful consideration on priority basis.
