Subject: INCLUSION OF MUNDKA AND PRAHLADPUR IN THE OFFICIAL DOCUMENTS PERTAINING TO INSITU REGULARISATION OF CLUSTERS OF INDUSTRIAL CONCENTRATION

We draw your kind attention to the draft regulations and guidelines for redevelopment of clusters of industrial concentration in non conforming areas / unplanned industrial areas.

We have approached DSIIDC for redevelopment of our cluster and have since been informed that our name doesn't feature in the 'MPD2021' covering 22 notified areas to be developed. Only 20 areas which were notified in the first phase have been named in MPD2021, whereas the following two areas which were subsequently notified have inadvertently not been included in the same:

1. Prahladpur Bangar having notification no.:1/C/CI/INSITU/Prahladpur Bangur/7/19 dated 11 September 2007.
2. Phirni Road, Mundka & Mundka Udyog Nagar (South Side) having Notification No:F-1/C.I./Policy/INSITU/Phirni Road, Mundka and Mundka, Udyog Nagar/2007/20 dated 17 September 2007 which was gazetted at Serial No.:160 on 17th September 2007. We enclose herewith a copy of the Gazette Notification, confirming our being one of the 22 notified areas for your ready reference.

The names of the above two areas are also not featuring in certain parts of Draft Zonal Plans and Draft Regulations and Guidelines based on MPD 2021.

We humbly request you to do the needful by including the above names in all the relevant documents and the intimation of the same may also be sent to all related departments.
