Dear Sir,

I, being president of Sr Citizen Corum Patel Nagar and originally migrated from West Pakistan and settled in year 1950 in your Resettlement Colony of L&DO at 8/28 South Patel Nagar New Delhi and is well aware with the ground realities of the area

Though these Colonies were developed in proper and planned manner having all type of facilities. But in the last 60 years due to high congestion of vehicles through out Delhi. The Parking Problem of our area too has become in tolerable. We have the option to give the suggestion as under.

That Patel Road where this South Patel Nagar colony exists is declared as Mixed land use and this area will be declared as fully Commercial as per your law. On this road there is a big plot where very old construction built for MCD Store as well as Medical dispensary of the Corporation. Because these activities are running very old and require renovation. The Sr. Citizens in the meeting had decided to convey their feelings that this big plot about 80 x 240 sq.ft ( plan attached ) may be redeveloped as a multilevel automatic parking ( under ground 3 levels ) and above should be a multi storey commercial complex where MCD office & dispensary and other basic needs and essential necessities of the residents may be utilized.

On 1<sup>st</sup>. of Oct. 2011 ELDERS DAY -- MINISTER SOCIAL WELFARE confirmed lot of help & Funds being provided for the registered bodies doing welfare activities for Sr. Citizens of the area . I may add here that I am also representing Patel Nagar to the New registered body CONFEDRATION OF SENIOR CITIZENS ASSOCIATIONS OF DELHI and could meet Chief Minister / Minister Social Welfare / Commissioner Police in connection with problems of Sr. Citizens and were assured all help to us the registered bodies of Delhi Sr. Citizens

In light of this we request you to please also approve complete roof top of the said building with four – five rooms for various welfare activities required in our area such as Libraries , Recreation Center and Space for Cultural Programs.
