Sub:- Public Suggestions on Mid-Term Review of MPD 2021 - Zone 'J'.

Re:- Widening of Shooting Range Road (Tuglakabad Fort) via
Karni Singh Shooting Range to Faridabad Border (Haryana).

Sir,

With reference to the advertisement dated 02.05.2012 and Open House Meet of South District held on 08.05.2012 in New Delhi on the above mentioned subject, I would like to state as under:

1). In August 2008, I had filed an enquiry under R.T.I Act 2005 with D.D.A regarding the widening of road for Shooting Range Road (Tuglakabad Fort) via Karni Singh Shooting Range to Faridabad (Haryana). I had received a reply from D.D.A from Director (T.T) reference no. F1(3)08/TT/Pt.XXIV/D-179 dated 22.08.2008 stating that Zonal Development Plan of Zone 'J' prepared under provision of MPD 2021 is not yet notified and is still in public domain. He also mentioned that the existing road has a width of approximately 6 to 8 mtrs, but, the proposed right of way for this stretch is 60 meters in the draft ZDP of Zone 'J' as on August 2008.

I am enclosing photocopies of three letters received by me from D.D.A in context to my R.T.I Application (Annexure 1 to 3) for your ready reference and record.

2). I understand that as on date i.e. May 2012, the Zonal Development Plan for Zone 'J' stands notified in which the right of way for this stretch is 60 meters.

As per information received from Municipal Corporation of Delhi under R.T.I this road is under their jurisdiction. The reply received from MCD under R.T.I dated 12th February 2009 is enclosed (**Annexure 4**) for your ready reference.

3). This road is one of the major connectivity for people travelling from Delhi to Faridabad and with increasing traffic on this road, the width is very narrow and prone to accidents.

Since the ZDP for Zone "J" stands notified and approved width of road is 60 meters, why the said road is not considered to be widened by Local Authorities? I would like D.D.A authorities to look into the matter and review the same and inform MCD about the approved 60 meters width of this road as per ZDP. D.D.A should advise MCD to widen the road giving relief to commuting public from Delhi to Faridabad.

4). Kindly take up the matter in Mid-Term review in D.D.A and issue necessary instructions for widening of the above mentioned road.

The parawise reply to the question is as follows:

1. This road is not a DDA road at present and the ownership is likely to be vested with the MCD as part of rural road.
2. This existing road has not been indicated in the plan of MPD-2021. The existing road has a width of approximately 6 to 8 mtr. and has also been indicated in the EICHR Delhi City Map. While detailing the zonal plan of Zone J, this road has been identified in the zonal plan and the proposed right of way is 60 mtr. however, the zonal plan of Zone J is under processing(public domain). The reply of Director of Zone J is also enclosed for your perusal.
3. After finalization of the zonal plan of zone J, the matter relating to right of way of the road will be finalized, at present there is no approved alignment plan of this road with TT Unit.
4. There is no information or alignment plan available with the TT Unit indicating the widening of this road.
5. Information not available with TT Unit of DDA.
6. There is no information available with TT Unit of DDA.
