Dear Sir,

We wish to bring to your notice the condition of 3 parks in Dwarka Sector 7.

- 1) Park located between Kamal Vihar Apartment Plot No. 5 and Harsukh Apartment Plot No. 4.
- 2) Park located in front of Gokul Garden and behind plot No. 1,2,3,4,5,6,7.
- 3) Park located between Palam extn and back side of plot No.8A,8B,8C,9, 10 and 11.

Our plan was to submit the RTI to find the following, however being aware of the fact that each RTI causes lot of paper and time wastage, we thought to approach and work out a plan directly with yourself and other concerned officers.

We Seek appointment at mutually convenient time with yourself and other concerned officers at park mentioned at Serial No.1. i.e. Park located between plot no 4 and plot no 5.

7. The number of lights which are in working condition presently with the date of their inspection.

Watering of grass, plants and trees

8. No tube wells exist in any of above mentioned parks , resulting in conversion of park into a desert. What steps/plans are underway to energize and make these tubewells functional?
9. What period of time will it take to make these tubewells functional?
10. When was the last inspection of the park (for water supply and tubewell functioning) was done? Please provide me with the copy of that inspection report and the office address and contact number of the person who did that inspection and prepared the report.

Cleanliness and Safety

11. What provisions are in place to ensure cleanliness and guarding/security of the park?
12. When was the last inspection of the park (for cleanliness and green cover) was done? Please provide me with the copy of that inspection report and the office address and contact number of the person who did that inspection and prepared the report.
