**Subject : Inadvertent Omission of part of our Industrial Area in the Zonal Plan**

In response to the advertisement by DDA in the national dailies we submit our suggestions pertaining to the above for your kind consideration:

Our Society represents a cluster of Industrial Area which was notified by the GNCTD vide Notification No: C.1/POLICY/INSITU/Phirni Road, Mundka and Mundka Udyog Nagar/2007/20 based on MOUD (Delhi division), Notification no S.O.141(E) dated 7th February 2007.

While going through the published Zonal Plans of Delhi we found that a part of our notified Industrial Area has not been shown in the Plans. Our area falls in two zones i.e. Zone K1 and Zone L.

While the plan of 'Zone L' is showing our area in the Land Use Map and also there is reference of our area in the Sr. No. 2.5 INDUSTRY. But the Zonal Plan -K1 neither mentions our areas nor have the provisions been indicated in the Maps, indicating the boundary of the notified areas. Under the Industry heading No: 2.6, there is no mention of our name, whereas 5 other clusters similarly notified and Gazetted have been included on the same page.

This was also taken up during the Public Hearing for Master Plan 2021 and we had raised the above anomaly vide our earlier correspondence as follows:

You are requested to look into the matter and arrange for incorporating suitable amendments in the Zonal Plan K-1 at your earliest convenience.
