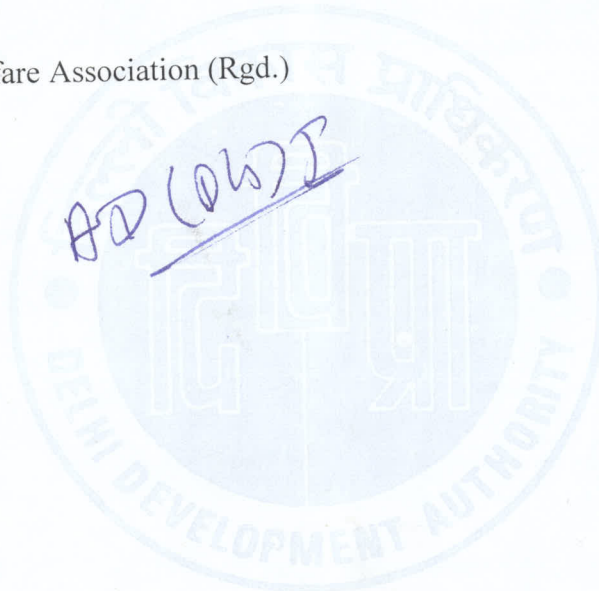
Sir / Madam,

We are hereby likely to submit our suggestions as under;

1. That flour area ratio for industrial plots up-to 100 sq. mts. should be increased to 240% (80+80+80) as working area other than 100% exempted basement for building maintenance & Parking.
2. That flour area ratio for industrial plots from 100 to 250 sq. mts. should be increased to 225% (80+80+65) as working area other than 100% exempted basement for building maintenance & Parking.
3. Rethala Metro should be extended to Holumbi Kalan Railway Station via Bawana Industrial area.
4. That charges for enhanced area should be nominal.
