Sub: - Suggestion regarding Master Plan 2021

Respected Sir,

We take this opportunity to bring to your kind notice about the plight of residents of Ashoka Pahari, who migrated from Pakistan and other occupants still living in the area for last 60 years and no improvement has been done so far.

This displacement of residents as said earlier from Pakistan is settled prior to 1948-49 in the areas as Ashoka Pahari, Jhandewalan/Upper Ridge Road/Naiwala, Karol Bagh, is occupation of this area for last 60 years.

All the people who migrated from Pakistan during Partition were assured in 1950 (Known as Gadgil Assurance) & damage payees and other occupants that they would not be evicted from the places in their occupation nor their construction would be removed. Some of the occupiers who came after partition, left the area after selling to present occupiers who got their names changed in DDA records as Damage Payees and some people lost their original documents. The land transferred hands so the present occupier may be treated as old occupier as DDA in its record accepts them as occupier.

The following points are to be noted so that justice is met to cause of deserving people. The area is not under Master Plan and neglected so far.

The undersigned on 15-05-12, in a meet at the IMA Hall had personally represented the people area and conveyed all in the video recording that was being held on the occasion of seeking suggestions.

We request you good self to include the area in Master Plan 2021 so that residents are settled here and the area is regularized, developed and
