-DWARA UPTO GAUTAM NAGAR INTERSECTION

1.0 AS per MASTER PLAN 2012, THE PROPOSED WIDTH IS 60 to 64 M for entire Aurobindo Marg as stated in para 10.2.1 Hierarchy of Roads ZONE-F

2.0 But the ACTUAL ROAD WIDTH NEED TO BE RESTRICTED DUE TO WIDTH OF 46 M TO 50 M OF AUROBINDO MARG BETWEEN the two portions of GREEN PARK METRO STATIONS ON EITHER SIDES OF THIS ROAD. Thus, Here "natural restriction" has taken place , FROM GURU-DWARA UPTO GAUTAM NAGAR INTERSECTION

3.0 This portion needs to retain exiting status keeping in view provisions of para 11.2 URBAN RENEWAL (ii) Yusaf Sarai. Therefore the provision for this Road be adopted & suitable incorporation in the Master Plan 2012 need be provided

4.0 Kindly arrange to notify this amendment as it also meets the SITE CONDITIONS.
