## OFFICE OF THE JOINT COMMISSIONER OF POLICE SOUTHERN RANGE: DELHI

The orders of the Hon'ble High Court of Delhi dated 15.12.2006 and 21.2.2007 are again reiterated that no construction should be allowed within 300 meters from the "present edge of river Yamuna". The zero point of measurement of 300 meters has also been clearly defined by the P.W.D. of G.N.C.T., Delhi. The PHQ has also issued directions vide No.24489-97/C&T (AC-V) (PHQ), dated 13.8.2009 in this regard.

The Yamuna – Removal of Encroachments Monitoring Committee headed by Justice Usha Mehra has also ordered the concerned SHOs to prevent construction in Yamuna River Bed. The committee vide letter dated 11.8:2009 has stated that complaints have been received regarding large-scale encroachments in Jaitpur, Molar Band, Village Aali, Village Madanpur Khadar, Village Jaitpur etc. The Chairperson observed that these colonies are in the Yamuna River belt and clear violation of the order of the Hon'ble Delhi High Court in this regard.

CP/Delhi has taken a very serious view of this and warned that SHOs ne held personally responsible for any unauthorized construction take place along the river belt in the Police Stations Jaitpur, Sarita Vihar, Badarpur and Jamia Nagar.

Addl.CP/SE District and ACP/New Friends Colony must ensure that SHOs take action on the ground and there is no encroachment within 300 meters of the water line along Yamuna bed in South-East District in general and in the area of Batla House Extension and Jogabnai Extension in particular.

SHOs/Sarita Vihar, Jaitpur and New Friends Colony must also ensure strict compliance of the above mentioned orders of Hon'ble Delhi High Court and of the Yamuna – Removal of Encroachments Monitoring Committee.
