Subject: Mid Term Revision of MPD-2021 regarding F.A.R.

Sir,

That Ministry of Urban Development, Government of India has decided to modify the M. PD. 2021 and the Zonal Development Plans of the area keeping in view the due need of the public and optimum use of the land in the public interest.

There is procedure as presented in the provisions of the so Act. 1957 under section 11 A of the said Act., and the Central Government may make any modifications to the Master plan and Zonal Plans of the area and for that there is a procedure in the said Act to invite objections and suggestions from any person with respect with proposed modifications in the said plan and Zonal plan. The main concept to modify the plan is to utilize the land and building in the wider interest of the public and maximum accommodation in the minimum area. Accordingly the FAR has been revised from the previous master plans. Still, there is a scope to increase the FAR in various field of the residential plot. Height should be allowed upto 15 mtrs for all the plots whether big or small.

In the unauthorized regularized colonies, the FAR have been allowed 100% whereas in the other residential area, this facility have not been extended to which in the public interest and on the basis of the need of maximum utilization the same facility is to be extended for residential plotted area. In this way the government will solve the problem of maximum accommodation of

the public in the minimum area if the FAR use are increased and disparity will among the colony will be equalized.

Most Important

Under these circumstances, it would be in the interest of the department to solve the problem of storage of accommodation. It is therefore prayed that the issue of increase of FAR may kindly be considered in the Light of human problem as the poor person cannot afford to buy the land and construct the house. He can raise further construction on the house which is available with them. It is submitted that sub-division have been allowed in the plot village abadides, special area and unauthorized Regularized colonies, sub-division that have taken place upto 2007 may be recognized provided that if there are more than one building in one residential plot.

If the above sub. division have been allowed in the specified area as mentioned above, it would be in the interest of the General Public that the above sub-divisions are also allowed in the plotted area of residential colonies and they may avail the benefit of the FAR as per area of the plot after sub-division. In this way, the number of dewelling units would be increased and the population would also be accommodated more than prior to the sub-division of the plot. We may not impose the date of restriction of sub-division, it should be open.
