With reference to the advertisement by Min. of Urban Development in the newspaper inviting suggestions, we submit our suggestion as under.

The Zonal Plan B-6 (includes Patel Nagar area) which was approved on 18.01.72 (copy enclosed), in which some blocks / plots, facing East Patel Nagar Market, were declared as **Convenient Shopping Centre (CSC)**. This was the extension of existing market in East Patel Nagar. The rows in Block No. 28, 29, 26, 25, 11, were included in this CSC.

In this regard, we want to point out the error which took place in this amendment/notification.

The row in BLOCK NO. 11, (from H.No. 15 to 23) should have included in this CSC. This row is more convenient, just facing the East Patel Nagar Market. **This is the right time to correct the error/mistake done in 1972.**

We request you to declare this row in **BLOCK NO. 11, (from H.No. 15 to 23)** as CSC. Please look into & decide on parity of law.

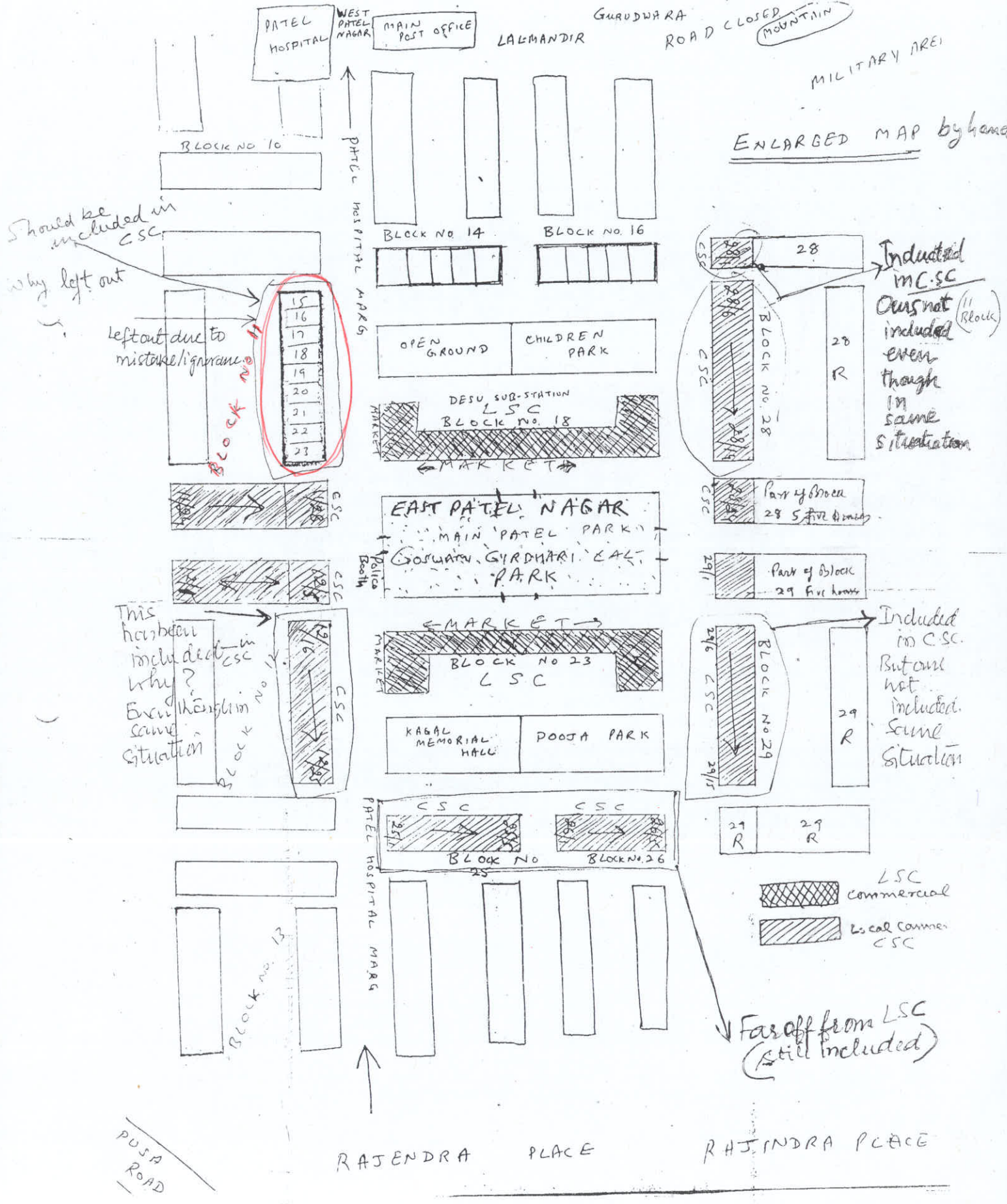
