1. We were involved in marble activities and were allotted plots in Sec.20, Service Centre, Dwarka, New Delhi-77.
2. The planning for Marble activities were done in year 1993 as per the provisions of MPD-2021 with following conditions imposed on shops:-

In the premises upon the implementation of MPD2021, the same also became applicable to Sector 20, Marble Market, Dwarka. Accordingly henceforth apart from Marble activity further services as set out in para 5 above could be carried with increased ground coverage and FAR as above in the Marble Market, Sector-20, Dwarka.

4. We are submitting before you the following disparity between Service Centre, Sector-20, Dwarka, New Delhi-77 & Mixed land users (other marble dealers)

5. The present scenario of marble usage in building has also been changed. Now mostly vitrified tiles, Wooden flooring, mosaic flooring, carpets, vinyl flooring, imported natural & engineered marble is used in building. To store these types of material we require covered space as these can't be kept in open.
6. Furthermore after the Hon'ble Supreme Court ban it is no more possible for traders to survive in the Marble Market by dealing in Marble exclusively when the very source has been ordered to be shut down
