Sub. : Representation on behalf of the Jhilmil Industrialists Association (Regd.) for Amendment of the Item no. 90 of annexure III containing the negative list of industries prohibited from operating within the National Capital Territory of Delhi.

Sir,

On behalf of the Jhilmil Industrialist Association(Regd.)an association of Industrialists ,we request you to kindly consider the following points concerning the "stainless steel pipes and tubes" while carrying out the exercise of the mid-term review of the working of the Master Plan for Delhi 2021 (for short "the MPD-2021")

1. The members of our association have been operating the stainless steel pipes & tubes industries in the national capital territory of Delhi for the last more than two decades. After obtaining requisite licenses /permission from the Delhi Pollution Control Committee (for short "the DPCC") and other concerned Government agencies.

2. Our submission is that the word "steel pipes & tubes" is under "ferrous metal category" means mild steel pipes & tubes. On the other hand stainless steel pipes & tubes come under "non ferrous metal category". These are all small scale units and ferrous steel pipes & tubes come under heavy & large scale industry.

3. Welding process of ferrous steel pipes & tubes is done by using ERW technology which creates pollution, also in ferrous steel pipes & tubes after welding by ERW technology Zinc galvanizing process is required whereas in stainless steel pipes & tubes no such process is required. In stainless steel pipes & tubes (Non-Ferrous) welding process is done by using TIG Technology, which is pollution Free.


