It is the considered opinion of the Town Planner/Developers and a "Universally Accepted Concept" that within the radius of 100 meters of authorised market all the lanes and strips should be commercial due to growth in population and increase/change in demands/requirements/necessities of life.

**So it is our humble request to declare the stretch adjoining market to declare commercial where there was commercial activity before 2007.**

A Survey by MCD was conducted in 2007 more than 50% commercialisation existed on this roads
