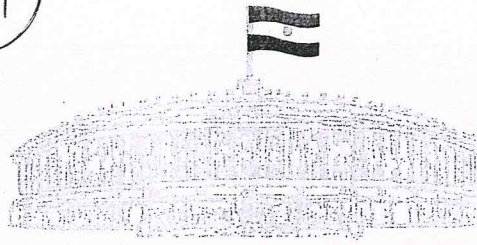

Respected Sir,

I, respectfully submit that the Delhi Transporters Association (Regd), which is the primary and biggest Association of Delhi and NCR has been seeking provisions in connection with the above subject since 2006, to decongest the city, by moving out of all whole sale Trade and all types of godowns and booking activities from the City to the periphery of Delhi, under the provisions of the Master Plan 2021.

The D.D.A Committee, also in its monthly meeting held on 06-09-2007 at Raj Niwas, Delhi, under the Chairmanship of Hon'ble Lt. Governor, Delhi, had suggested to earmark separate areas in all the Zones for godowns of transport companies. 1851e

The Hon'ble High Court of Delhi had in its order dated 28.05.2004 sought the de-congestion and de-commercialization of whole sale trade in the congested Walled city and Special area. Again in its order dated 5th October, 2007, the Hon'ble High Court of Delhi had issued directions to get the survey and verification of transport godowns completed by 31st Oct. 2007 and action taken report on the same be submitted to them.

The D.D.A on 03-02-2010, wrote to the Commissioner, MCD to send the detailed survey conducted in this regard. The Survey was duly completed in June, 2010 and the survey report has since been sent to the Chief Town Planner, MCD, Delhi.

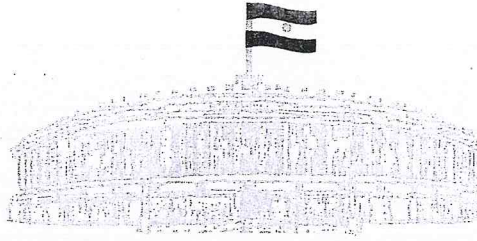

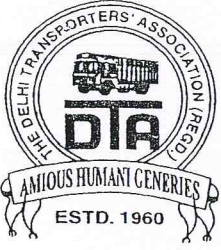

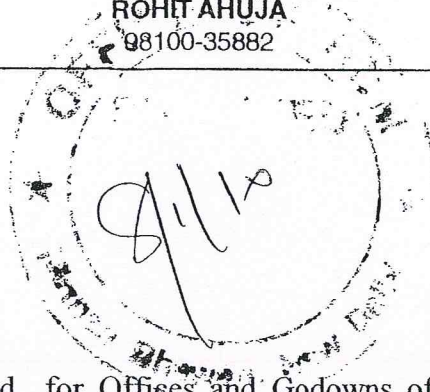

We have been engaged in this trade before Independence and our activities have been mainly in the wholesale trade involving booking and delivery of all types of goods and their transportation within and outside Delhi. Their Offices and Godowns are mainly concentrated in the Special Area of walled City, its Extension and Karol Bagh

We feel proud of your remarkable achievements for MASTER PLAN-2021, for Delhi, a milestone in the development, beautification and pollution free Delhi of the 21st century. Indeed this Master Plan-2021, will go a long way in raising the health, status and standard of living of the ever increasing population of Delhi.

We respectfully submit that we have been seeking provision for offices and godowns of booking agencies since 2006 as per Master Plan 2021 which suggests that adequate goods transport infrastructure needs to be developed urgently. Tajendra Khanna Committee had also recommended under Chapter IV that "ALL THE WHOLE SALE MARKETS SHOULD BE MOVED FROM WITHIN THE CITY TO THE PERIPHERY. ALONGSIDE SUCH MARKETS, GOODS TRANSPORT YARDS SHOULD BE BUILT TO FACILITATE MOVEMENT OF FREIGHT CARRYING VEHICLES."

E.C.P.A was also issued directions by the Hon'ble Supreme Court of India, to look into issues relating to the subject matter. A copy of the E.P.C.A report dated 27-08-2006 is enclosed. However, the final recommendation of the E.P.C.A is reproduced below:

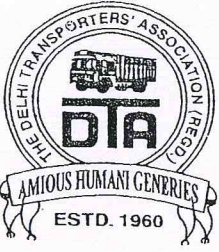
" EPCA is reluctant to give a sweeping recommendation on this issue. EPCA therefore, recommends that the concerned agencies namely MCD and DDA should confer with the traders and other concerned groups to evolve a relocation Plan, with clear milestones and schedules. It is important that this plan is evolved with the participation of the affected parties and implemented."

The D.D.A Committee, also in its monthly meeting held on 06-09-2007 at Raj Niwas, Delhi, under the Chairmanship of Hon'ble Lt. Governor, Delhi, had suggested to earmark separate areas in all the Zones for godowns of transport companies.

The Hon'ble High Court of Delhi had in its order dated 28.05.2004 sought the de-congestion and de-commercialization of whole sale trade in the congested Walled city and Special area.. Again in its order dated 5th October, 2007, the Hon'ble High Court of Delhi had issued directions to get the survey and verification of transport godowns completed by 31st Oct. 2007. and action taken report on the same be submitted to them. The Hon'ble High Court had also ordered that the aforesaid godowns shall be closed after the expiry of 6 months from the date of completion of the verification.

We had also got prepared A REPORT ON INFRASTRUCTURE REQUIREMENTS OF DELHI TRANSPORTERS AT PROPOSED INTEGRATED FREIGHT COMPLEX IN NARELA SUB-CITY. We had been writing letter to the Hon'ble Lt. Governor of Delhi and other various concerned authorities on the subject, forwarding therewith a copy of this report for taking necessary action in this regard.. Copy of all theses letters and the report are submitted for your kind perusal We have also submitted our objections/suggestions for the modification in the respective zonal plans of Delhi. We have also attended personal hearings of the objections/suggestions before the Board constituted for the purpose.

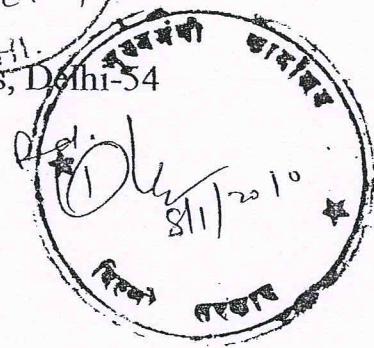

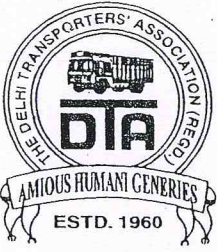


