RE. : Paper Godowns in Different Parts of Delhi.
Suggestions For Master Plan - 2021.

Respected Sir,

As you are aware that wholesale market of Paper & Paperboard is established in Walled City mainly at Chawri Bazar etc. These markets are existing since more than a century and are meeting the demand of Delhi and adjoining states. The paper is an essential commodity which is used for Educational purposes in printing Educational Books, Newspaper, Magazines, Periodicals etc. The Paper is eco Friendly and is manufactured out of agricultural Residue. Population of Delhi has increased rapidly since partition & hence business has also increased. To store the huge quantity of paper, requirement of Godowns was felt. Neither DDA nor the government has ever allotted the space to store this quantity of Paper. In the absence of any policy of DDA & other Government Agencies in this regard, it became necessary for the traders to construct godowns at their own cost/rent in the border areas of Delhi on Lal dora, extended Lal dora & agriculture land which was never objected by any agency. Recently DDA had allotted smaller size plots to the Paper Merchants to decongestion in the Walled City. Even the above plots allotted by DDA are yet to develop by the traders & do not full full fill the 10% of the requirement of storage of Paper.

Sir, the Urban Development Ministry's time to time bring Amnesty Bill prohibiting sealing and demolition of Farmhouses, institutions, Godown on Agricultural Land, vendors and slum dwellers & including unauthorized colonies too. The Panic of sealing by the MCD - Delhi Government department to the Paper Godowns which are constructed on Agricultural Land/Lal Dora/ Extended Lal Dora remain on our members.
