The Executive Engineer (E.), Electrical Division No.9, DDA on behalf of Delhi Development Authority invites/Re-invited online Item rate tenders from approved and eligible contractors of DDA, CPWD and those of appropriate list of M.E.S. Railway, BSNL and (Specialized firm who meet the conditions given below) for the following work(s).

The tender document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen from website www.tenderwizard.com/DDA OR www.dda.org.in free of cost.

The enlistment of the contractors should be valid on the last date of submission of tenders.

In case only the last date of submission of tender is extended, the enlistment of contractor should be valid on the original date of submission of tenders.

Those contractors not registered on the website mentioned above, are required to get registered beforehand. The intending bidder must have valid Class-II digital signature to submit the bid.

Earnest money and cost of tender to be deposited through RTGS/NEFT in the account of Sr. A.O. / CAU Rohini Zone / DDA having S.B. Account No.1347200011 with Central Bank of India, Rohini Branch (IFSC Code CBIN0283348. The unique transaction reference of RTGS/NEFT shall have to be uploaded by the Tenderers in the e-tendering system by the prescribed date. The Executive Engineer / ELD-9 will get tender cost / earnest money verified from CAU based on the unique transaction reference number against each RTGS/NEFT payment before the tenders are opened.

A part of earnest money is acceptable in the form of Bank Guarantee also. Earnest Money upto Rs.20.00 Lacks will have to be deposited through RTGS/NEFT mode. If the amount of E.M. is more than Rs.20.00 Lacks then the amount of E.M. beyond can be deposited in the form of Bank Guarantee also. Such Bank Guarantee is to be scanned and uploaded to the e – tendering website within the period of tender submission.

Earnest money and cost of tender have to be deposited through separate transactions.

- i) Cost of Tender Document as mentioned against each work to be deposited through RTGS/NEFT in the account of the Sr. A.O. (CAU) Rohini Zone/DDA.
- ii) E-tendering processing Fee as mentioned against each work to be deposited through E-Mode to ITI Limited in favour of M/s ITI Limited payable at Delhi).

The unique transaction reference of RTGS/NEFT against EMD Cost of Tender Document and Bank Guarantee shall be placed in single sealed envelope superscripted as Earnest Money, Cost of Tender Documents with name of work and due date of opening of the bid mentioned thereon will submit to tender opening Authority i.e. EE/ELD-9/DDA by the due date mentioned below. Copy of Enlistment Order and Certificate of work experience as required shall be scanned and uploaded to the e-tendering website within the period of tender submission and certified copy of each shall be deposited in a separate envelop marked as "Other Documents".

Both the envelopes shall be placed in another envelope with due mention of Name of work, Date & time of opening of tenders and to be submitted in the office of Executive Engineer / ELD-9 during the period mentioned below.

Online tender documents submitted by intending bidders shall be opened only of those bidders whose UTR of RTGS/NIFT against Earnest Money Deposit, Cost of Tender Document and other documents placed in the envelope are found in order.

Specialized Conditions for work mentioned at Sr. No.1 & 7

1. The annual financial turnover (gross) in Electrical construction works in one of the three preceding financial year shall not be less than 100% Estt. Value of work (duly audited by Chartered Accountant) on annualized basis (depending upon the time allowed for the completion i.e. total estimated value divided by time of completion).
2. The satisfactorily completion of similar nature/class of work each costing as below in the Central / State Govt. / Public Sector Undertaking/Govt. Autonomous Body during the last Five year/Seven years. The firms / contractors shall produce proof from the appropriate authority from the officer of rank not less than the rank of Executive Engineer.
 - (I). Three similar works each costing not less than the 40 % of the Estt. Cost of the proposed work. OR
 - (II). Two similar works each costing not less than the 60 % of the Estt. Cost of the proposed work. OR
 - (III). One similar work costing not less than the 80 % of the Estt. Cost of The proposed work.
