

Sub: Effective use of 'Arogyasetu' App for breaking the chain of transmission of COVID-19.

In continuation to this office circular dated 20.04.2020 and having regard to DoPT's guidelines dated 29.04.2020 on the subject cited above, the following directions may strictly be followed to improve the safety of all DDA officials:

- (i) All the officers, staff (including outsource staff) working in DDA should download 'Arogyasetu' App on the mobile phones, immediately.
- (ii) Before starting for office, they must review their status on 'Arogyasetu' and commute only when the App shows 'safe' or 'low risk' status.
- (ii) The officers/staff are advised that in case the App shows a message that he/she has a 'moderate' or 'high risk' calculated on the basis of Bluetooth proximity ("recent contact with infected person"), he/she should not come to office and self isolate for 14 days or till the status becomes 'safe' or 'low risk'.
- (iv) All HoDs should ensure that above directions are strictly followed in the respective Departments of DDA.
- (v) Security staff to see green status of 'Arogyasetu' App alongwith thermal scanning before allowing employees for entering premises.
- (vi) Report on the action taken may be sent to this office.
