राष्ट्रमंडल खेल गांव खेल परिसर में निम्नलिखित कार्यों के लिए दिल्ली डेवलपमेंट अथॉरिटी (स्पोर्ट्स विंग) की ओर से ई-निविदा प्रक्रिया के माध्यम से ऑनलाइन निविदाएं आमंत्रित की जाती हैं। निविदा दो भागों में अपलोड की जाएगी, अर्थात् 'पार्ट - एक' में तकनीकी बोली और 'भाग- दो' शामिल है जिसमें 'वित्तीय बोली' शामिल है। निर्धारित तरीके से अपलोड नहीं की गई बोली को बिल्कुल भी नहीं माना जाएगा केवल उन एजेंसियों / फर्म / व्यक्ति, जिन्होंने निविदा में डाल दिया गया अनुमानित लागत का 40% से कम नहीं, या दो समान पूर्ण किए गए कार्यों की लागत के समान रूप से तीन समान प्रकृति कार्य पूर्ण कर दिए हैं, प्रत्येक लागत निविदा में लगाए अनुमानित लागत का 60% से कम नहीं है, या पिछले एक सालों के आखिरी दिन समाप्त होने वाले आखिरी दिन समाप्त होने वाले अंतिम अनुमानित लागत के 80% से कम लागत वाली लागत के साथ ही सरकारी विभाग या सार्वजनिक क्षेत्र के वार्षिक उपक्रम का 30% से अधिक खर्च चार्टर्ड एकाउंटेंट द्वारा विधिवत प्रमाणित मार्च 2018. को समाप्त करने वाले तत्काल अंतिम तीन लगातार वित्तीय वर्ष के दौरान प्रत्येक वर्ष आवेदन करने का हकदार है उसके एक प्रमाणिक तकनीकी बोली के साथ अपलोड किया जाना चाहिए। निविदाकर्ता को व्यापार और कर विभाग, जीएसटी / जीएनसीटीडी के साथ पंजीकृत होना चाहिए और निविदा के साथ पंजीकरण की एक प्रति प्रस्तुत करना चाहिए।

Online tenders are invited **through e-tendering mode** on behalf of Delhi Development Authority, (Sports Wing) for the following works at CWG Village Sports Complex. **The tender shall be uploaded in two parts, namely, 'Part -I' containing Technical Bid and 'Part – II' comprising 'Financial Bid'. The bid not uploaded in accordance with the prescribed manner will not be accounted for at all.** Only those agencies/ Firm/ Person **having successfully completed three similar nature of works** each costing not less than 40% of the estimated cost put to tender, or **two similar completed works** each costing not less than 60% of the estimated cost put to tender, or **one similar completed work** costing not less than 80% of estimated cost put to tender during the last five years ending previous day of last date of submission of tender in Government Department, Public Sector Undertaking, Govt. Schools with annual turnover more than 30% of the estimated cost in each year during the immediate last three consecutive financial year ending March 2018 duly certified by Chartered Accountant are entitled to apply. A proof thereof should be uploaded with the Technical Bid. The tenderer should be registered with the Department of Trade & Taxes, GST, GNCTD and furnish a copy of registration with the tender.

1. The unique transaction reference on NEFT/RTGS against EMD shall be placed online at specified location for Tender for above work. First cover containing “Technical Bid” as well as “reference of EMD”.
2. The technical Bids shall be opened online at 11.00 AM on **13.03.2019** in the presence of a committee or their representatives by authorized bid openers. Financial Bids of only those tenderers shall be opened whose technical bids qualify, at a time and place of which notice will be given. The Tenderer technically qualified will be at liberty to be present either in person or through an authorized representative at the time of opening of the Financial Bids with the Bid Acknowledgement Receipt or they can view the bid opening event online at their remote end.
3. The Tenderer should furnish **Rs. 1,14,760/-** as Earnest Money in the form of RTGS. The amount will be retained by DDA as part of security deposit, in case tender is accepted, otherwise it will be refunded. However, no interest payable on the earnest money.
