#### **TERMS & CONDITIONS:**

- 1. The supply should be carried out as per specification and direction of Secy/YSC.
- 2. Nothing extra shall be paid to the agency.
- 3. The supply should be completed within 30 days after issue of Supply Order.
- 4. The payment will be made after entire satisfaction of Secretary (YSC).
- 5. No T & P will be issued by the Department.
- 6. The tenders shall be valid for 90 days from the date of opening of financial bids.
- 7. Any conditional tenders shall be summarily rejected.
- 8. Any tenders received through post / courier etc. shall be summarily rejected.
- 9. The tenderers should be registered with the Department of Trade & Taxes, Govt. of NCT of Delhi.
- 10. The tenderers should submit GST registration Certificate.
- 11. Debarred agency/or individual shall not be permitted to participate in the tenders process
- 12. The payment will be made after entire satisfaction of Secretary (YSC).
- 13. The supplier of the Archery Kit having more than 5 years' experience in the field of supplying of Archery kits
- 14. a) **Specification of Dresses (T-shirts & Short Pant)**:- Complete dry fit material with dot net back with sleeves sublimation, collar sublimation and both sides dress sublimation with DDA Logo.
  - (b) **Specification of Kit Bag**:- Good quality of approved brand bag pack.
  - (c) **Specification of Inner** :- Good quality Lycra stretchable.
  - (d) **Specification of Upper Jacket, Half Jacket & Lower**:- Micro top with net inner. Top fully sublimated with both sides sublimation and lower with the same material with DDA Logo.
- 15. In case the rates quoted by the bidders are same, then in order to arrive at a decision, a draw of lots shall be carried out by a Committee comprising of Secretary of the Complex, Sr. AO (Sports) and DDO of the Complex.
- 16. Every bidder is requested to be registered compulsory himself under GST/IGST/UGST/SGST Act.
- 17. TDS under the provision of GST law shall be deducted from the bills and / or payment of advance as and when made applicable under the GST Act.
- 18. Provision of GST Act 2017 shall have the superseding effect over the all earlier taxes like VAT/WCT/ServiceTax/ Other like taxes etc. as contemplated in the Act. Accordingly, the terms VAT/WCT/Service Tax/ etc. appearing anywhere in the bid documents may be read as the applicable tax under the GST Act 2017. Further these shall be subject to revision in the conditions as and when incorporated in the modified CPWD Works Manual & Insurance of modifications issued by Govt. of India, in the matter, from time to time. The modification shall be followed in to as per requirements of the GST Act-2017.

Note(1):- The bidder will use one UTR for one work only. In case, it is found that he has used one UTR number for different tenders, all the tenders submitted by him will be rejected and he will be debarred from further tendering in DDA in future."
