The Earnest money shall be deposited through RTGS/NEFT in to the account of Sr. A.O./CAU (NZ), DDA having A/C No. **0287111000022 with HDFC Bank, B-3-2 Ashok Vihar phase II, New Delhi-110052 (IFSC Code HDFC0000287) & MICR CODE 110240039**. The unique transaction reference of RTGS/NEFT along with proof of e-registration fee (along with GST) paid shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date.

A part of earnest money is acceptable in the form of bank guarantee also. Earnest money up to Rs.20 lacs will have to be deposited through RTGS/NEFT mode. If the amount of EM is more than Rs.20 lacs then the amount of earnest money beyond Rs.20 lacs can be deposited in the form of Bank Guarantee which will remain in force up to and including the last date of 90 days after the deadline for submission of tenders such bank guarantee shall also be scanned and uploaded on the e-tendering website within the period of tender submission.

The tenders shall be issued to class-I contractors of DDA and CPWD. The tenders shall also be issued to non DDA , Non CPWD class-I contractors registered with BSNL, MES & railways provided they have satisfactorily completed three similar nature of works, each of value not less than 40% of the estimated cost or two works of similar nature, each of value not less than 60% of the estimated cost or one work of similar nature of value not less than 80% of the estimated cost in last seven year ending last date of month previous to the month in which tenders are invited.

Note: Class-II contractors of DDA & CPWD shall also be eligible if they satisfy the above criteria.
