CIRCULAR

Sub: Revalidation of Possession Letters issued to the allottees who did not turn up for taking over the physical possession of plot from 2014 onwards under Rohini Residential Scheme-1981.

It has been decided by the Competent Authority that, in order to mitigate the hardship faced by the allottees/ applicants, a final opportunity is being given to those allottees whom possession letters were issued from 2014 onwards and had not taken the physical possession of plot within stipulated period, may apply for revalidation of their possession letter upto 31.12.2019 with proper reasons for not taken the physical possession within stipulated period and subject to the payment of restoration charges and penalties, as applicable. These cases will be decided on the merits of Director (RL), DDA.


