 - ii) Completion certificates of the works mentioned above shall be considered for pre-qualification.
(During scrutiny of cases, the value of work executed by a firm sometime earlier shall be brought to current costing level by enhancing the value of work done @ 7% per annum (calculated from date of actual completion to the current date without compounding) for eligibility criteria for above mentioned works).
 - iii) Solvency certificate issued by Nationalized Bank/ Scheduled Bank for **40%** of estimated cost of work.
 - iv) Annul financial turnover of **50%** of estimated cost during last 3 years ending on 31st, March 2012.
