Sub: Permission for temporary use of sq. ft. land measuring 2600 sq. mts. on date 27/9/11 to 6/10/11 for religious/social/marriage function at site Guru Teg. Bahadur Park Kirti Nagar

Please refer to your application dated 11/8/11 regarding booking of vacant land for temporary use to hold religious and marriage. You are hereby granted permission to hold religious/social marriage function on account of USE IDDA's name of Guru Teg Bahadur Park measuring 2600 sq. mts. on 27/9/11 to 6/10/11 on temporary use in the following terms & conditions as already accepted by you.

- The land booking for temporary use permitted above shall not be misused for any other purpose. If any misuse is found at site the land shall be vacated with force without any notice in this regard and IDDA shall not be responsible for any damage or loss in this regard. In such eventuality, your security deposit shall stand forfeited.
- The said land shall also be vacated by IDDA at your risk and cost if more land is encroached than permitted above or more than the permitted days as above. Under such circumstances IDDA shall not be responsible for any damages or losses in your moveable properties. Your security deposit shall also be forfeited under such circumstances.
- The temporary booking is not allowed in case it is found by the field staff of IDDA that temporary booking has been obtained by you misrepresenting the facts, and/or practicing any fraud or in through impersonation, the permission so granted shall automatically stand cancelled and you will be liable for eviction forcibly, besides criminal proceeding, for forfeiture of your security deposit. IDDA shall not be liable for any damage and/or losses sustainable to your moving such forcible eviction.
- It must that on IDDA's premises, i.e. boundary wall, grill fencing, gates, roads & trees etc. is damaged. In case of any damage in this regard your security deposit shall stand forfeited or to the extent of the value damage.

- 5 You shall have to ensure the fire safety norms prescribed by the Chief Fire Officer (CFO) DDA shall have no responsibility of any fire accident or damage due to your carelessness, carelessness or sheer negligence. (Copy enclosed)
- 6 No parking vehicles inside the DDA's vacant land is allowed.
- 7 You shall have to make your own arrangement for water, electricity etc.
- 8 Except hand held sprayers, DDT, physical instruments and fluid etc. is subject to various Acts laws in force and you will have to get permission where it is required from the authority concerned.
- 9 In case the banking is cancelled due to any reason by you and the intimation of this cancellation is made before one month from the date of fixation you shall be entitled for 90% and 30% refund if intimation is made before 15 days from the date of fixation. No refund shall be allowed if the intimation is within the 15 days from the date of fixation. Such refund shall be allowed only on properly aboves requests and these orders shall be applicable with prospective effect.
- 10 Banking as permitted above is non-transferable. In case of unauthorized transfer of banking is detected by field staff of DDA, both the parties i.e. unauthorized transfer and transferee shall be liable for penal actions besides cancellation and forfeiture of security deposit.
- 11 DDA reserves the right to cancel the said permission without any notice in case of violation of the said terms and conditions.
- 12 DDA also reserves the right to withdraw its mission under forced circumstances without any liability or claim of damages and losses from your side.
