Subject: Permission for temporary booking of land measuring 2000 sq. mts. from date 27/11/11 to 29/11/11 for religious/social/marriage function at 4th floor, Mussoorie L.N.O. 3.

Please note in your application dated 17/8/11 regarding booking of vacant land for temporary use to hold of religious marriage. You are hereby granted permission to hold religious/social function on account of ~~use~~ DDA's building at 4th floor, Mussoorie L.N.O. 3, 2000 sq. mts. on 27/11/11 to 29/11/11 for temporary booking on following terms & conditions as already mentioned below:

The said booking for temporary use as mentioned above shall not be misused for any other purpose. If any damage is found at site, the land will be vacated with force without any notice and DDA shall not be responsible for any damage in loss or damage in such eventuality, your security deposit shall stand forfeit.

The said land shall also be vacated on risk and cost of more land as is required then permitted. In case that the permitted days are above, under such circumstances, DDA may be liable for any damages or losses in your unavoidable circumstances. Your security deposit shall also stand forfeit.

If the party booking is not allowed to do so as found by the said staff of DDA that temporary booking has been done with misrepresenting the facts, and/or practicing any fraud, in such an instance, the permission so granted shall automatically stand cancelled and you will be liable for criminal liability, besides criminal prosecution. In forfeiture of your security deposit, DDA shall not be liable to pay any amount towards sustenance to your during such forcible evictions.

It must that no DDA's property like boundary wall, grill fencing, gates, etc. shall be damaged in this regard and no damage or value damage

in place to carry the five units max prescribed by the Chief Fire Officer. DDA shall have no responsibility of any fire incident or damage due to your slackness, carelessness or sheer negligence. (Copy)

1. No parking vehicles inside the DDA's circuit board is allowed.

2. You will have to make your own arrangement for water, electricity etc. for the stand and Food Speakers. DDA Alcohol arrangements and Board etc. is subject to various Acts Laws in force and you will have to get permission where it is required from the authority concerned.

3. If you are the booking is cancelled due to any reason by you and the minimum of 15 days cancellation is made before one month from the date of function you will be entitled for 90% and 50% refund if cancellation is made before 15 days from now. No refund shall be allowed if the cancellation is within the 15 days from the date of function. Such refund shall be allowed only in properly given requests and these orders shall be applicable with prospective effect.

4. Booking as permitted above is non-transferable. In case of unauthorized transfer of booking is detected by field staff of DDA, both the parties i.e. the concerned transfer and transferee shall be liable for penal actions besides deduction and forfeiture of security deposit.

5. DDA reserves the right to cancel the said permission without any notice in case of violation of the said terms and conditions.

6. DDA also reserves the right to withdraw permission under forced circumstances without any liability or claim of damages and losses from your side.
