3. The intending tenders must have at least one year for work at Sl. No. 1, five year for the works at Sl. No. 3 experience of providing security in the govt./semi govt. organization.

4. Tender form will be issue to those who will fulfill the condition as per the security act 2005.

5. Before one day of selling of tender (Last date of submission of tender) the contractor would have to show all the documents in the office of concerned Dy. Director.
