- The tenders are open to Class-I DDA and CPWD enlisted contractors as per their enlistment. The tender shall also open to MES, Railway & BSNL contractors of appropriate class(having tendering limit upto the estimated cost put to the tender) but with the condition that they


have satisfactorily completed three similar nature of works each of value not less than 40% of the estimate cost put to tender or two similar nature of works each of value not less than 60% of the estimated cost put to tender or one work of similar nature of value not less than 80% of the estimated cost put to tender in the last 7 years ending previous day of last date of submission of bid. The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to the last date of submission of bid.

4. The tender is also open to Class II Contractor of DDA and CPWD provided they have completed the similar work as stipulated in para (4) of PWD-6.
5. The intending tenderer should ensure before tendering in DDA that the requisite e-tendering fee has already been deposited with CRB, DDA.
6. Every tenderer / bidder is required to be registered compulsorily under GST Act for Delhi state
7. Every tenderer/bidder shall have registration with EPFO, ESIC and BOWC welfare board, whatever applicable before submission of bids.


