UNDERTAKING TO BE GIVEN BY THE CLIENT/SPONSOR FOR BOOKING OF THE COURSE

M/s thank the DDA for booking of the Qutab Golf Course for golf tournament scheduled on We hereby accept all the conditions stipulated below for use of the golf course for tournament on

- The course will be booked from 7.00 AM to 1.00 PM. (Shot gun start).
- The field for the tournament will not be more than 120.
- **Slots. 25 slots for an event on Saturday/Sunday/Holiday will be given to the Management irrespective of the number of individuals who are having Playing Rights of Qutab Golf Course and have been invited by the sponsor.**
- **Financial Aspects.** The details of payment alongwith schedule are exemplified below:-
 - (a) **Booking charges are as under (including GST):-**

❖ Weekdays	Rs.2.05 Lakh	}	This payment should reach our office minimum four weeks prior to date of tournament.
❖ Saturday	Rs.3.80 Lakh		
❖ Sunday/Holiday	Rs.5.05 Lakh		
 - (b) **Hoarding / Signages.** A maximum of 5 hoardings will be allowed as part of the booking charges. Any additional hoarding will be permitted on payment of Rs. 5000/- + GST per hoarding. This amount should be paid one week prior to date of the tournament.
 - (c) **Stalls.** Rs. 5000/- + GST will be paid per day per stall of 12'x12' feet. This amount should be paid one week prior to date of tournament.
 - (d) **Caddie Fees / Breakfast / Lunch.** Caddie fees @ Rs. 500/- will be paid by the organizers. Breakfast and Lunch will be provided to caddies by the organizers including those caddies whose turn does not come during the tournament.
- **Vehicle Display.** Charges for display of two cars of the same company will be Rs. 25000/- + GST per car, per day. In case of two wheelers the charges will be Rs. 10000/- + GST per day for 2 x 2 two wheelers of the same company.
- It will be assumed that you have accepted the terms & conditions of the Organizer/Sponsor prior to submitting advance payment, which will be submitted alongwith your request. **Balance payment must be paid 4 weeks before commencement of the event. The Course will be formally booked on receipt of advance payment i.e. Rs. 50,000/- (Non – refundable).** The booking will be liable to cancellation if the advance payment or the balance payment is not done as per schedule specified above.
- The Committee Members of the Qutab Golf Course may be invited at an appropriate level.
- Skill prizes will not be allowed to be displayed at the fairways. The sponsors can give coupons for skilled prizes, which can be collected after the game.

- No tipping, no cash awards etc. to the staff/caddies on the course.
- Type of decoration, erection of Shamiana, Stalls will be approved by the Management.
- Only two carts will be made available i.e. two seater free of cost. Additional carts if required for organizers and for dropping of players to Tees may be on payment at the prescribed rate.
- **Food and Beverages. All food and Beverages (Soft & Hard) will be served through the licensed agency, of the Qutab Golf Course. Outside catering and sponsored liquor is not permitted.**
- **Bar License.**
 - (a) Copy of the bar license to be handed over to the DDA, Qutab Golf Course, one day before it is required.
 - (b) The Sponsor/Organizer will be responsible, in totality, for any infringement of the rules of the Excise Deptt., for serving of drinks.
- No signages/advertisement (Direct or Indirect) relating to liquor or tobacco will be displayed.
- Any correspondence, like invitation letters from the organizers, where the name of DDA, QGC figures, will not have any logo/advertisement relating to tobacco/liquor (direct or indirect).
- We have no objection to the work of renovation of greens / fairways / tee / driving range being done during the tournament.
- **Organisers must strictly follow the COVID-19 protocols during the event.**
- **Use of facemask and social distancing is mandatory at all times within the Golf Course premises.**
