**PRESS RE-TENDER NOTICE**

Sealed tenders are re-invited by the Delhi Development Authority (Sports Wing) for engagement of an Agency/ Firm for prevention of trespassing, for Watch and Ward and security Surveillance Services at Siri Fort Sports Complex. The tender shall be in two parts, namely, 'Part One' containing Technical Bid and 'Part-II' comprising 'Financial Bid'. The two Bids shall be submitted in two separate envelopes clearly subscribing thereon (Part I- Technical Bid) and (Part II- Financial Bid). Only Agencies/Firms/ Persons having undertaken three similar works during the last five years in Government Department's/ Public Sector Undertakings are entitled to apply. The tenderers must be registered with the Provident Fund Commissioner, E.S.I and Service Tax Department etc. and the proof thereof should be enclosed with Technical Bid. The work is as follows.

**NAME OF WORK :** M/o Siri Fort Sports Complex **S H :** Engagement of Firm/ Agency for prevention of Trespassing, watch and ward and security Surveillances services at Siri Fort Sports Complex by providing 9 nos. Security Guards without T & P article for 6 days in a week (except Monday & National Holiday).

**PERIOD:** One year.  
Tender document containing detailed terms & conditions can be obtained from Cashier, Siri Fort Sports Complex on payment of **Rs. 500/-** (Non Refundable) towards the cost of tender documents on all working days between **11:00 A.M. to 3:00 P.M.** up to **18.08.2008** along with earnest money of **Rs. 10,000/-** payable by Demand Draft/ Call Deposit receipt of any schedule bank approved by Reserve Bank of India drawn in favour of Siri Fort Sports Complex. The tender document complete in all respect should be submitted to the office of the Siri Fort Sports Complex, August Kranti Marg, New Delhi latest by 3 P.M. on **21.08.2008**. The Technical Bids shall be accompanied by attested copies of documents in support of experience and financial standing etc. The 'Part-One' Tender containing the Technical Bid shall be opened on the same at 3.30 P.M. in the presence of those tenderers or their representatives who may wish to be present at the site. The Financial Bid of only those tenderers, who are found to be technically qualified, shall be opened on a subsequent date to be notified and intimated to the qualifying tenderers by post, through Courier as well as telephonically.  
The tenders shall be submitted in person only and any tender received by post or through courier etc. shall not be entertained, and shall stand rejected even without scrutiny of the same. Further any tenders which are not accompanied by the earnest money in the prescribed manner shall be rejected summarily.
