Sealed item rate tenders are invited for the following works by EE/RPD-13/DDA/Rohini, Delhi-110085 on 6.10.08 up to 3.00 p.m. on behalf of D.D.A. from the approved contractors of appropriate class of D.D.A., CPWD, MES, Civil Wing of P & T and Railways, which shall be opened on the same day at 3.30 p.m. at DDA Press Building, Vikas Sadan, near INA market, New Delhi in the presence of intending tenderers or their authorized representatives.

The tender documents can be had on any working day from the tender sale counter at DDA Press Building, Vikas Sadan, near INA Market, New Delhi between 11.00 a.m. to 3.00 p.m. on payment of cost of tender (Non-refundable) on production of valid Enlistment Certificate issued by any of the department mentioned in Para-1, certificate of registration with works contract cell of Sale Tax/VAT Deptt. of GNCTD and tax clearance certificate issued by the Works Contract Cell. The tenderers are advised to inspect the site, drawing and NIT before tendering. The amount should be quoted in figures as well as words. The item-wise and total tendered amount should be also worked out.

The earnest money should accompany the tender in the form of call deposit receipt/demand draft of a scheduled bank guaranteed by R.B.I. in favour of Sr. Accounts Officer, CAU(R)/DDA. The earnest money may also be deposited in the form of F.D.R., which should be pledged in favour of 'E.E./RPD-13,DDA' and should be valid for at least six months after the last date fixed for receipt of tender.
