Office, INA, New Delhi on indicated dates. The enlistment of the contractor should be valid on the last date of sale of tenders. In case only the last date of sale of tender is extended, the enlistment of contractors should be valid on the original date of sale of tenders. In case both the last date of receipt of applications and sale of tenders are extended, the enlistment of the contractor should be valid on either of the two date i.e. Original date of sale of tender or on the extended date of sale of tender.

Tender documents can be obtained on payment of cost of tender (non refundable) as well as amount of Earnest Money mentioned against each work in the appropriate form as given in PWD-6 attached with the tender documents and on production of valid certificate from the CAU/SEZ, DDA and Centralized Tender Office at Vikas Sadan.
