Conditions : Conditions for all the works mentioned at Sl.No. 1 to 5

- Specialized firms/contractors who fulfill the following requirements whether registered with CPWD/DDA or not shall be eligible to apply. Joint ventures are not accepted
 - Should have satisfactorily completed (at least one of them in Central Government/Central Autonomous body/Central PSU) either three similar works each costing not less than 40% of the estimated cost or two similar works each costing not less than 60% of the estimated cost or one similar works costing not less than 80% of the estimated cost during last Five years ending last day of the month previous to the one in which applications are invited. The applicant shall submit certificates from clients/owners in support of his claim. Such certificates shall be signed by an official not below the rank of Executive Engineer or Project Manager or equivalent. Similar works shall mean mechanized/automated housekeeping work of non residential buildings which shall include mechanized cleaning of building durable and non-durable furniture.
 - Shall have average annual financial turnover of at least 50% of estimated cost during immediate last three years ending March, 2008. The applicant shall submit a statement duly certified by chartered Accountant or ITC certificate in support of his claim.
 - Shall possess machines used in the housekeeping work, of book value of not less than Rs. 35 lacs. The applicant shall submit duly certified copy of balance sheet of the year ending March, 2008 or any other proof to the satisfaction of the competent authority in support of his claim
 - Should not have incurred any loss in more than two years during the last five years ending March, 2008 duly certified by the Chartered Accountant, Per return submitted by the applicant to the income tax department
 - Should produce a solvency certificate of 40% of estimated cost of work certified by the bankers (Note: the bankers will be any of the scheduled Banks as per RBI act).
 - Attested copies of all the documents are required to be submitted along with the application.
- Tenderer should possess valid ISO: 9001 Certification for Housekeeping services,
- If any information furnished by the applicant is found incorrect at a later stage, he should be liable to be debarred from tendering/taking up of work in CPWD/DDA. The department reserves the right to verify the particulars furnished by the applicant independently
- Intending agencies should apply with details about criteria as mentioned above.
- The department reserves the right to reject any application/tender without assigning any reason. The enlistment of contractors should be valid on the last date of sale of tenders. In case only the last date of sale of tender is extended, the enlistment of contractor should be valid on the original date of sale of tenders. The contractor should be registered Delhi Value Added Tax (DVAT) Act 2004 and must produce along with the application the attested copy of such registration and acknowledgement upto date filed returns submitted to the Department of Trade & Taxes,. Delhi The contractor should submit certificate copy of registration certificate under Employee Provident Fund Act and Service Tax registration certificate.
