The earnest money should accompany the tender in the form of call deposit receipt/demand draft of a scheduled bank guaranteed by RBI in favour of Sr. A.O. (CAU), Rohini, DDA, The earnest money may also be deposited in the form of FDR, which should be pledged in favour of Executive Engineer concerned. The amount should be quoted in figure as well as in words. The item-wise and total tendered amount should also be worked out. Tender documents consisting of plans, specifications, the schedule of quantites and the set of terms and conditions of contract can be seen in the office of the respective EE between hours of 11.00 AM to 3.00 PM.

The enlistment of the contractors should be valid on the last date of sale of tenders.
