Footnote 1:
Eligibility criteria for issue of tender documents for works would be as under:
(a) For works costing upto Rs. 25.00 lacs, in case of B & R tenders shall be issued to contractor(s) registered with DDA only;

Footnote 2:
Special Conditions for work at Sl.No - 1:
(a) For works costing above Rs. 2 crores but upto Rs.10 crores, the tenders shall be issued to DDA as well as non-DDA contractors provided they have satisfactorily completed three similar nature of works, each of value not less than 40% of the estimated cost or two works of similar nature, each of value not less than 50% of the estimated cost or one work of similar nature of value not less than 80% of the estimated cost in the last 7 years ending last day of the month previous to the one in which the tenders are invited.
(i) The condition of similar nature of work is not applicable to the registered contractors of Class-I of DDA
(ii) Class 2 contractor of DDA & CPWD shall also be eligible if they satisfy the criteria specified above.
(b) The annual financial turnover in the similar nature of work in one of the preceding three financial years shall not be less than 100% of the estimated (Gross) value of the work (Duly audited by Chartered Accountant) on annualized basis (depending upon the time allowed for completion i.e. total estimated cost / value divided by time of completion).
(c) The contractor shall have his own hot mix plant (batch type) 100-120 PPH and paver finisher fitted with electronic sensor device for automatic levelling and profile control within the specified tolerance and required supporting machinery including vibratory road rollers etc. as per MORTH specifications
(d) Tender will be issued from the office of EE/SED-5, DDA, Vasant Kunj, New Delhi-110070.
(e) Similar nature of work means.....C/O Road work as per MORTH Specifications.
