Those contractors not registered on the website mentioned above ,are required to get registered beforehand The intending bidder must have valid class-II digital signature to submit the bid.

Earnest money and cost of tender shall be deposited through RTGS/NEFT in the account of Sr. A.O./ CAU (NZ) DDA having account no 0637000100356153 With Punjab National Bank, Ashok Vihar Branch(IFSC

code PUNB 0063700).The unique transaction reference of RTGS/NEFT shall have to be uploaded by the tenderer in the e- tendering system by the prescribed date .

A part of earnest money is acceptable in the form of bank guarantee also. Earnest money up to Rs.20.00 lacs, will have to be deposited RTGS/NEFT mode. If the amount of E.M in more than Rs. 20.00 lacs then the amount of E.M beyond Rs. 20.00 lacs can be deposited in the form of Bank Guarantee also. Such Bank guarantee is to be scanned and uploaded to the e- tendering website within the periods of tender submissions.

Earnest money and cost of tender have to be deposited through separate transactions.

Online tender documents submitted by intending bidders shall be opened only those bidders whose Earnest Money deposit, Cost of Tender Document and e-tendering processing fee and other documents placed in the envelope are found in order.
