If any misuse is found at site, the land shall be vacated with force without any notice in this record and DDA shall not be responsible for any damage or loss on this account. In such eventuality, your security deposit shall stand forfeited.
- 2. The said land shall also be evicted forcibly at your risk and cost if more land is discounted then permitted above or more than the permitted days as above. Under such circumstances, DDA shall not be responsible for any damages or losses to your moveable properties. Your security deposit shall also be forfeited under such circumstances.
- 3. The proxy booking is not allowed. In case it is found by the filed staff of DDA that temporary booking has been obtained by you misrepresenting the facts, and or practicing any fraud and/or through impersonation, the permission so granted shall automatically stand cancelled and you will be able for eviction forcibly, besides triminal proceedings an forfeiture of your security deposit, DDA shall not be liable for any damage and/or losses sustainable to your during such forcible eviction.
- 4. If must that on DDA's property such as boundary wall, grill fencing, gates, roads and trees etc. Is damaged. In case of any damage in this regard your security shall stand forfeited besides recovery of the value damage.
