Whereas M/s. Arya Builders, C-62, Rajgarh Colony, Gali No. 8, Gandhi Nagar, Delhi-110031 is enlisted in DDA as Class-IV (Civil) with its validity upto 28.01.2014 vide this office order No. 21 dated 24.02.2009.

A work of restoration of roads and path at Mayur at Mayur Place, Mayur Vihar, Ph-I was awarded to the agency on work order vide refer No. 02/EE/ED-14/DDA/11-12. Amount of work order was Rs.2,23,606.00.

In connection of said work order, Chief Engineer (EZ) informed that a complaint was received in Vigilance Branch that the work has not been executed and the payment was being made without execution of the work. Subsequently, the agency deposited the amount of work order along with interest @ 18% in May, 2013 after a notice to deposit the said amount was issued by the then EE/ED-14.

The agency, therefore, was served a Show Cause Notice to submit his explanation in the above matter. The agency submitted the explanation vide its letter dated 22.09.2014.

Whereas the reply was sent to CE (EZ) for submission of his specific comments. The comments of CE (EZ) were received wherein he recommended that the disciplinary action against the agency be taken.

The case in entirety was placed before the CRB in its meeting held on 08.12.2015. Now after careful consideration, the CRB has decided to debar M/s. Arya Builders from further tendering in DDA for a period of one year from the date of issue of this order.
