- 1. The Project consists of treatment of Drain / Sewer waste to make it fit for Horticulture use in DDA parks, installation of sewage treatment plants, other suitable treatment methods, Environment Management Services etc. to meet out the water requirement of parks and to defunct the bores being used for water extraction in DDA parks as per the direction of NGT).
- 2. Executive Engineer, Eastern Division-4 on behalf of VC, DDA intends to appoint a Consultant to provide services for Project Management consultancy for the project. The cost of Consulting Services shall be financed out from the maintenance head of Various Scheme under NA-II, East Zone (2018-19).
- 3. DDA intends to shortlist competent consultancy firms / consortium of firms to participate in competitive bidding for "Project Management Consultancy " The objective role of the Project Management Consultant is to assist DDA for following issued.
 - i. Availability of STP water nearby the green areas.
 - ii. Availability / Feasibility of existing sewer line / SW Drain passing through the green areas or along roads.
 - iii. To study the quantity of raw water available vis a vis requirement of each park.
 - iv. To work out the feasibility to club the parks / greens and make groups of park / green which are in closed vicinity in order to plan a common treated system in one of the major park and to supply in other in nearby vicinity smaller parks.

Expression of Interest (EOI) from reputed consultancy firms / consortium of firms having experience in relevant Project Management Consultancy services in design, engineering and implementation of STP, other advance / latest methods for treatment of drain / sewer waste for Horticulture use to be collected from trunk mains, branches, laterals, pumping stations, pumping mains and sewage treatment plants (both conventional and advanced type with final disposal and/or reuse of treated waste water as well as experience in non - sewerage works. 4. Eligibility:

Following eligibility / qualification criteria will be used to shortlist the applicants (single firm/joint venture/consortia):

- a) The applicants may be an independent single firm or in joint venture or in consortium / association with other firms;
- b) In the EOI it must be clearly indicated / stated who the "Lead Partner" is, if it is a joint venture / consortium. The Lead partner should demonstrate adequate experience in Project Management Consultancy in similar sewerage projects in India or in Developing Countries having individual project cost of a minimum (Indian rupees) 10 million (1.00crore) in last 7 Years as well as experience in non-sewerage works such as community toilet complexes, installation of onsite sewerage treatment in eco-digesters Biotoilets, public awareness & participation and institutional development & capacity building of urban local bodies etc.
- c) The applicants should have experience in projects of comparable size, complexity, and technical specialty in India and other developing countries as well as experience in the developed countries. The applicants shall exhibit experience in sewerage projects consisting of development of engineering designs for STPs, other suitable methods for waste water treatment, Environment Management Services for onsite sewerage treatment facilities, preparation of bid documents, technical and financial evaluation of bids, construction review, GIS mapping, institutional development and capacity building of urban local bodies, public awareness campaigns, etc.
- d) The Lead partner should have adequate capability to handle staff resources, project delivery capability, national/International expertise, financial capability, etc.

- e) The Lead partner shall exhibit experience of working in externally aided projects (multilateral or bilateral) for State or Central Government organizations in India;
- f) The Lead firm should have an annual average turnover of minimum of 10 million (1.00 crore) for the last three years ending March 2018 and each of the partner(s) should have an annual average turnover of minimum of 0.25 million (25 lac) for the last three years ending March 2018. The intending firm(s) has to be profitable and should not have incurred loss in the last three financial year ending March, 2018.
- g) The EOI document must include:
- (1) List of similar assignments completed successfully in the last 7 years and list of ongoing projects started in last 7 years with brief project description, brief of the services provided by the applicant in the project, relevancy, information of cost of the services provided/ being provided, cost of project, employer and funding agency;
- (2) Company profile and a list of permanent employees, number of years of association of each employee with the company and their relevant skills;
- (3) Short CVs of the Technical Experts proposed for the project and having relevant experience;
- (4) Project delivery capability in countries having similar conditions as in India and experience with internationally funded projects in India (on-going or completed);
- (5) Company registration certificate/s and document/s of Latest Annual Report and audited accounts;
- (6) Document/s clearly showing last three (3) year annual turnover figures;
- (7) Eligibility statement.
- h) Applicants having special experience for providing consultancy services in (a) Best Practices for Energy Management in STPs (b) Asset Management (c) Accounting and fund management (d) GIS Mapping of sewerage / water supply works shall have added advantage in evaluation of proposals. Applicants shall indicate briefly their special experience separately in the EOI.

After submission of the EOI, change in the Lead consultant and or joint venture / consortium partnership, shall not be permitted. As on the date of notification of EOI, the consulting firms barred from participating in any project funded by Govt. of India and other international are not eligible to participate in this project. Declaration to that effect shall be furnished. Further only short listed consultants shall be invited to submit their detailed proposal for the Project Management Consultancy. The evaluation of the detailed proposal shall be carried out through Quality and Cost Based Selection (QCBS) method.
