- 11. The validity of the quotation is 60 days from the date of opening of the sealed quotations.

- 12. Debarred agency/or individual shall not be permitted to participate in the tendering process.
- 13. Any individual who has been debarred is not permitted to take part in any negotiations or represent an agency even if he holds a power of attorney on the agencies behalf. Any agency engaging debarred persons is also liable to debarring.
- 14. The quotationer should be registered with the Department of Trade & Taxes, GST/GNCTD and supposed to furnish a copy alongwith quotation otherwise the quotation may not be considered and liable to be rejected.
- 15. GST Compliant Invoice must be submitted. Itemwise CGST and SGST must be mentioned and aggregate value of SGST and CGST should be computed clearly. Other requirement like mentioning GST No. of supplier as well as DDA GST number can also be complied with.
- 16. Pre-receipt bill in Triplicate must be submitted for release of payment.
