On-line tenders are invited by the undersigned on behalf of Delhi Development Authority (Sports Wing) for the work: - Running of Pro-shop (Sports Equipment) at the newly constructed Club House and Pro-shop alongwith Snack Bar at Driving Range at Qutab Golf Course, DDA on Monthly License Fee Basis for a period of one year. The tender shall be in two parts viz 'Part-I' containing Technical Bid and 'Part-II' comprising 'Financial Bid'. Only those agencies having a minimum of three years experience in the field of Running of Golf Pro Shop and having a minimum average annual turnover of Rs. 50.00 lacs from running of pro-shop only for the last three financial years are entitled to submit the tenders. The bid not submitted in accordance with the prescribed manner will not be accounted for. The Pro Shop is located at the newly constructed club house having a total covered area of 93.56 Sq.mtrs. at Qutab Golf Course, DDA Press Enclave Road, New Delhi 110017.

In Part – I of the tender, i.e. Technical Bid, the tenderer shall upload details of ownership/management of the agency, experience of similar nature of works undertaken by them i.e. copies of award letters and certificates of satisfactory completion, duly attested, authenticated proof showing annual turnover, manpower available with them, their qualifications and experience in the field etc. In case of company/firm, an attested copy of registration certificate and Article of Association is also to be furnished. In case of a partnership firm, the partnership deed, registration will be submitted and in case of a proprietorship firm the details of all proprietors and the percentage ownership in the proprietorship concern.

In Part – II of the tender should contain financial bid indicating monthly license fee (per month) offered by the tenderer. The offer should be given in both words & figures.
