TENDER NOTICE (SPECIALISED WORKS)

Sealed high rate tenders are invited for the following work by the Executive Engineer (E), Electrical Division No.12, Central Nursery, Sector-5, Dwarka upto 3.00 P.M. on behalf of DDA from the approved contractor of appropriate class of DDA, CPWD, MES, Railway, P & T and specialized firms who meet the following conditions:-

1. The annual financial turnover (gross) in Elect. Construction work in one of the preceding 3 financial years shall not be less than 100% of the estimated (gross) value of the work (duly audited by Chartered Accountant) on annualised basis (depending upon the time allowed for completion, i.e. total estimated value divided by time of completion).
2. The satisfactory completion of at least two works of similar nature / class each costing not less than 50% of the estimated cost (gross) of the proposed work in the Central/state Govt. / or in public sector undertaking / Govt. autonomous bodies during the last five years.
3. The tender shall be opened by the same date at 3.00 P.M. Ground Floor, Vikas Minar, DDA Office, I.P. Estate, New Delhi in the presence of intending purchaser or their authorized representative.
4. The tender documents can be obtained on any working day from the office of Executive Engineer (E) / Electrical Division - 12 DDA between 11.00 AM to 3.00 P.M. on payment of cost of tender (non-refundable) as well as amount of Earnest Money mentioned against each work on production of valid enrolment certificate WCTC on form XI sale of tender forms will be stopped four days (including the date of opening) before the date fixed for the opening of tender documents.
5. The manner of submission of tender, opening of same and entry of contractor's / their authorised representative of the place of opening shall be as provided in Clause - 3 a), (b) & (c) of PWD-6 forming part of the tenders.
