2. \*The promotion of Shri Pushpender Kumar Sharma S/o Sh. Lal Kishore Sharma is provisional subject to the outcome of the revision petition filed by the CBI against order of discharge dt. 18.7.19 in FIR No.RC-DAI-2017-(A)/0034 dt. 07.11.17. As per DoPT instructions vide OM dated 19.01.2017, his promotion thus will be without prejudice to the action that may be taken if the judgment of the Trial Court acquitting the Government servant is set aside. In case on appeal the Government servant stands convicted, following action will be taken:

- The provisional promotion shall be deemed non-est, and the Government servant shall stand reverted;**
- In case of the Government servant being sentenced to imprisonment exceeding 48 hours, he will be deemed to be under suspension in terms of rule 10(2)(b) of CCS (CCA) Rules, 1965, from the date of conviction;**
- Action under rule 19(i) of the CCS (CCA) Rules, 1965, read with OM No. 11012/11/85-Estt.(A) dated 11<sup>th</sup> November, 1985 and 4<sup>th</sup> April, 1986 shall be taken.**

3. No financial benefits shall be allowed to above named official/officer, if they had already been granted benefit of financial upgradation under ACP/MACP Scheme in level-11 of Pay Matrix as per 7th CPC [Pre-revised Pay Band of Rs. 15600-39100/- with Grade pay of Rs. 6600/-]. If not granted, their pay will be fixed under the provisions of FR22(I)(a)(1). They may exercise their option for fixation of pay under the provision of FR22(I)(a)(1) within 30 days from the date of issue of this order.


