On line sealed item rate tenders are invited through E-tendering mode for the following works by the Executive Engineer WD-5 1<sup>st</sup> Floor, Vikas Minar, I.P.Estate, New Delhi-110002 on behalf of DDA upto 3.00 P.M. on (Mentioned below) from the approved and eligible contractors of appropriate class of the DDA which shall be opened through e-tendering mode.

Earnest money and cost of tender shall be deposited through RTGS/NEFT in the account of Sr.A.O. CAU(NZ) having account No.0637000100356153 with Punjab National Bank, Ashok Vihar branch (IFS Code PUNB 0063700). The unique transaction reference of RTGS/NEFT shall have to be uploaded by the tenderer in the e-tendering system by the prescribed date. The Executive Engineer concerned will get tender cost/earnest money verified from CAU based on the unique transaction reference number against each RTGS/NEFT payment before the tenders are opened.

A part of earnest money is acceptable in the form of bank guarantee also. Earnest money upto Rs.20.00 lacs will have to be deposited through RTGS/NEFT mode. If the amount of EM is more than Rs.20.00 lacs then the amount of E.M. beyond Rs.20.00 lacs can be deposited in the form of Bank Guarantee also such bank guarantee is to be scanned and uploaded to the e-tendering website within the period of tender submission.

The Unique transaction reference of RTGS/NEFT against EM and cost of tender document and Bank Guarantee shall be placed in single sealed envelope superscripted as "Earnest Money and Cost of Tender Documents" with name of work and due date of opening of the tender mentioned thereon and will submit to tender opening Authority by. The officer inviting tenders shall have the right of rejecting all or any of the tenders and will not be bound to accept the lowest or any other tender.
