L.G., Delhi/Chairman, DDA has been pleased to approve the revised rates of Medical Allowance/Annual Ceilings for reimbursement of the expenditure incurred on OPD treatment in respect of the Staff/Officers and Pensioners as below:-

Group 'C' and 'D' employees who are at present getting monthly Medical Allowance @ Rs.250/- and Rs.230/- per month respectively have also been covered under the Medical Reimbursement Scheme. In their case, the annual ceiling for reimbursement has been fixed at Rs.10,000/- and Rs.7,500/- respectively. This shall be optional. Options once exercised shall be final and irrevocable. Onus to obtain the options in the enclosed format shall rest with the Drawing and Disbursing Officer concerned and entry to this effect shall be kept in the service records of the official concerned to govern their claims. The Drawing Officers shall further ensure that proper records are maintained and the annual ceilings are not crossed under any circumstances. They shall get the requisite Medical Cards issued in each case from the Accounts Officer (Medical), DDA. however, a particular official does not opt for the reimbursement schemes, he shall be entitled to continue with the prevalent system and get Monthly Medical Allowance at the enhanced rate of Rs.425/-& Rs.325/- per month respectively.

Persons granted financial upgradation (s) under ACP Schemes will be entitled to the Medical Allowance/Annual Ceilings of reimbursement as per the original status/post.

The revised rates/ceilings shall be effective from 01.04.2009 and remain in force till further orders.
